The National Archives and Records Administration (NARA) has received information that a Merchant Seaman's Personnel and Licensing Records file that was requested from the Atlanta Federal Records Center (FRC) was lost during shipment after it was requested by a Coast Guard office.

In accordance with 36 CFR 1230.14, we are requesting that the USCG provide NARA with a report including the following information:

- A complete description of the records with volume and dates if known;
- The office maintaining the records;
- A statement of the exact circumstances surrounding the removal, defacing, alteration, or destruction of records;
- A statement of the safeguards established to prevent further loss of documentation; and
- Details of the actions taken to salvage, retrieve, or reconstruct the records.

The National Archives and Records Administration (NARA) has received the report from the United States Coast Guard (USCG) regarding a box of 28 Merchant Seaman Records that was discovered to be missing after the USCG National Maritime Center requested it from the Atlanta Federal Records Center (FRC) in September 2022. The records are from the USCG Regional Exam Center - Miami.

We understand that the FRC was unable to locate the files within their facility and the records were unable to be reconstructed. The USCG National Maritime Center has updated their lost file reporting procedures to ensure that files lost during shipment are reported to the FRC within 5 days of unsuccessful receipt of shipments. Procedures also require completion of the CG-5212 form within 5-7 days of receiving notification that records are missing in transit, and notification of the USCG Agency Records Officer within 30 days of original notification or loss.

Based on the information we received in your report, we consider this matter to be resolved. I appreciate your attention to this matter.
