Dear Mr. Siskel:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the systematic processing projects and Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 20,171 pages and 13,128 assets, have been reviewed for all applicable FOIA exemptions, resulting in 1,104 pages and 226 assets restricted in whole and 711 pages and 6 assets restricted in part. NARA is proposing to open the remaining 18,356 pages and 12,896 assets in whole and 711 pages and 6 assets withheld in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Freddy Ford, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is May 29, 2024, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

The remaining items cover unrelated events and meetings occurring during this time period. These materials are from the White House Office of Records Management Subject Files, White House Office of Appointments and Scheduling, and White House Office of Strategic Initiatives. Electronic records proposed for opening consist of emails regarding the timing and participants of the meeting, a schedule request, approved presidential activity memoranda, a weekly report from the State Department dated April 11, 2001, a suggested energy issues document for the meeting from the Department of Energy, discussion of gifts for the Argentine President, a pool report about the meeting, and emails requesting verification of meeting dates. These electronic records are from the Automated Records Management System (ARMS), Exchange Email, WHO Shared Drive Search and Access Sets.

Much of this material consists of invitations, reports, and correspondence to and from White House Chiefs of Staff Andrew (Andy) Card and Joshua (Josh) Bolten, as well as Senior Advisor Karl Rove. The vast majority of these records do not directly relate to Bill Gates, and most of the records that are responsive to this request contain only passing references to him. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the systematic processing projects and Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 20,171 pages and 13,128 assets, have been reviewed for all applicable FOIA exemptions, resulting in 1,104 pages and 226 assets restricted in whole and 711 pages and 6 assets restricted in part. NARA is proposing to open the remaining 18,356 pages and 12,896 assets in whole and 711 pages and 6 assets withheld in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is May 29, 2024, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
