Dear Mr. McGahn:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open Clinton Presidential records in response to the Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 38,816 pages, have been reviewed for all applicable FOIA exemptions, resulting in 4,620 pages restricted in whole or in part. NARA is proposing to open the remaining 34,196 pages. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President Clinton's representative, Bruce Lindsey, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is April 25, 2018, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

Subjects include birthday greetings and wedding congratulations, condolences from President Clinton to Kennedy upon the death of his mother, Kennedy's appointment to the Presidential Committee on Mental Retardation, and Kennedy's attendance at the screening of an HBO special. The majority of the records revolve around the events as they unfolded after the plane crash that killed John F. Kennedy Jr., his wife, and his sister-in-law. These records include President Clinton's hand-edited statement on the disappearance of the plane; worldwide news media coverage; drafts of statements to be made upon the location of the wreckage; internal and external reactions to the disappearance; condolence messages and letters from foreign heads of state; the National Transportation and Safety Board's investigation of the incident; public response to the use of the Coast Guard and U.S. Navy to search for the wreckage; and

responses to Kennedy's burial at sea. TIME Magazine published a commemorative issue featuring Kennedy after his death, which is also included in these records.

Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is April 25, 2018, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
