Dear Mr. Siskel:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the systematic processing projects and Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 41,504 pages and 1,371 assets, have been reviewed for all applicable FOIA exemptions, resulting in 1,746 pages and 436 assets restricted in whole and 277 pages and 66 assets restricted in part. NARA is proposing to open the remaining 39,481 pages and 869 assets in whole and 277 pages and 66 assets in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Freddy Ford, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is January 2, 2024, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

Bush Presidential electronic records proposed for opening include emails of news articles, draft remarks by President George W. Bush after meeting with his National Security Team, and emails related to administrative or routine office functions. The NSC Shared Drive records include drafts of the Iraq strategy review event timeline. The WHO Shared Drive records include block calendars of the Chief of Staff, cabinet reports, and NSC meeting summaries. These materials are from the Exchange Email, NSC Shared Drive, and WHO Shared Drive Search and Access Sets.

There are memoranda from the White House Counsel's Office discussing revisions to the laws regarding presidential succession, historical and legal background on presidential succession, drafts of presidential letters to the Speaker of the House and President Pro Tempore of the Senate regarding the invocation of the Twenty-Fifth Amendment, and press releases detailing President George W. Bush's physicals and his use of the Twenty-Fifth Amendment to temporarily transfer presidential authority to Vice President Dick Cheney. These materials are from the White House Office of Records Management and the White House Counsel's Office.

This researcher submitted a Freedom of Information Act (FOIA) request for Staff Member Office Files (SMOF) related to Thomas "Tom" P. Bossert between January 1, 2007, and January 1, 2008. The George W. Bush Presidential textual records proposed for opening are reports, memoranda, lists, talking points, briefings, correspondence, handwritten notes, forms, information sheets, itineraries, resumes, and printed emails. The materials cover Mr. Bossert's activities as Special Assistant to the President for Homeland Security and Senior Director for Preparedness Policy. There are drafts of reports relating to national security topics, including the Department of Homeland Security's National Response Framework, the National Strategy for Homeland Security, Homeland Security Presidential Directive 8 (HSPD-8), and Chemical Facility Anti-Terrorism Standards. Also included are notes, agendas, and briefings for meetings and conferences concerning telecommunications, national security professional development, GPS capabilities, and critical infrastructure protection. Personnel files, mostly involving Mr. Bossert's security clearance and access to the White House, can be found here as well. All personally identifiable information present in these records has been withheld. These materials are from the Homeland Security Council, White House Office of Management and Administration, Office of Administration – Office of Security and Emergency Preparedness, White House Office of Presidential Personnel, and Office of White House Personnel.

This researcher submitted a Freedom of Information Act (FOIA) request for all documents in the White House Office of Records Management files that contain any reference to Scott Pruitt, Administrator of the Environmental Protection Agency. The George W. Bush Presidential textual records proposed for opening are letters and resolutions from state and local leaders, organizations, and individuals expressing concerns over or requesting presidential support for a variety of legislation, political policies, and regulations from 2001-2004. This includes a letter and resolution from Scott Pruitt regarding Celebrating the Centennial of Baseball in Oklahoma and model legislation named The Jury Patriotism Act. Also included are routine working documents from the Office of Karl Rove such as press briefings, memoranda, printed emails, focus group poll results, and invitations relating to a variety of issues including tax reform, the compassionate agenda, economic recovery, faith-based initiatives, abortion, and affordable housing. A small amount of material relates to unsolicited resumes, letters, applications, and candidate recommendations, including one resume listing Scott Pruitt as a reference. There is a large portion of correspondence requesting letters of congratulation, greeting, acknowledgement, or photographs from President George W. Bush and some draft replies, including one photo of President George W. Bush and Laura Bush inscribed to Margaret and Scott Pruitt. These materials are from the White House Office of Records Management.

There are multiple schedules, guest lists, and briefings for the event, as well as biographies for the Gala's honorees. In addition, there are daily schedules for President George W. Bush from December 2003 and event memoranda for a White House reception for the Kennedy Center honorees, a photo opportunity with White House social aides, and the White House official holiday portrait. These materials are from the White House Office of Records Management Subject Files. Electronic records proposed for opening consist of news articles, reports, press releases, mailing lists and labels, guest lists, briefing points and a court opinion from the US Court of Appeals for the Fourth Circuit: Hodges v. Abraham, et al. The bulk of the electronic materials are related to President George W. Bush's appearance at the Kennedy Center Honors Gala held on December 7, 2003. These electronic records are from the Automated Records Management System (ARMS), Exchange Email, Exchange Email Restored - 21 Days, Exchange Email Restored - 33 Days, Exchange Email Restored - 40 Days, RNC Personal Storage Table (PST), OA Shared Drive, OPD Shared Drive, WHO Shared Drive, and Worker and Visitor Entry System (WAVES) Search and Access Sets.

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to you, as former President George W. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the systematic processing project and Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 41,504 pages and 1,371 assets, have been reviewed for all applicable FOIA exemptions, resulting in 1,746 pages and 436 assets restricted in whole and 277 pages and 66 assets restricted in part. NARA is proposing to open the remaining 39,481 pages and 869 assets in whole and 277 pages and 66 assets in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is January 2, 2024, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
