Dear Mr. Siskel:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the systematic processing projects listed in Attachment A.

These records, consisting of 27,603 pages, have been reviewed for all applicable FOIA exemptions, resulting in 399 pages restricted in whole and 144 pages restricted in part. NARA is proposing to open the remaining 27,060 in whole and 144 pages in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Freddy Ford, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is April 16, 2024, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

While most of these records concern Chief of Staff Andrew (Andy) Card, National Security Advisor and Secretary of State Condoleezza Rice, White House Counsel and Attorney General Alberto Gonzales, and Office of Homeland Security Director and Secretary of Homeland Security Tom Ridge, many of the records in this segment contain comments or references from or about other Cabinet members. These materials are from the White House Office of Records of Management Subject Files, the White House Counsel's Office, and the White House Office of Homeland Security.

The George W. Bush Presidential Library has completed the systematic re-review of records closed under a Presidential Records Act (PRA) restriction within FOIA 2014-0227-F. The George W. Bush Presidential textual records proposed for opening are primarily reports, resolutions, statements, remarks, Q&A, press points, talking points, handwritten notes, schedules, annotated routing sheets, printed emails, and memoranda, most of which are drafts that contain proofreading edits, suggested wording, and/or remarks of an advisory nature. There are draft letters responding to members of Congress and other public organizations, and periodic reports to Congress, such as the periodic report on the National Emergency with Respect to Iraq and the Status of U.S. Efforts Regarding Iraq's Compliance with U.N. Security Council Resolutions. The correspondence to Congress and public organizations primarily addresses concerns and opinions expressed about the situation regarding Iraq by stating the administration's general, overarching policy and plans on the topic. Also covered in these records are routine memoranda of conversations and memoranda of telephone conversations, some of which are marked unclassified and others which have been declassified under mandatory declassification review. These include conversations with Prime Minister Anders Fogh Rasmussen of Denmark, Prime Minister Fatos Nano of Albania, and President Hosni Mubarak of Egypt, among others. Furthermore, one will find mainly routine head of state correspondence, some of which are marked unclassified and others which have been declassified under mandatory

declassification review. These include correspondence with Prime Minister Jose Maria Aznar of Spain, Prime Minister Junichiro Koizumi of Japan, President Rolandas Paksas of the Republic of Lithuania, and President Vaclav Havel, among others. Additionally, there are briefing papers, memoranda, discussion papers, unclassified white papers, printed legal material, talking points, and letters discussing the topic of the legal authority and justification for the use of military force against Iraq. Examples of other topics found within this set of records are drafts covering topics such as the United Nations Security Council Resolution 1441, the 2002 Iraq Liberation Act Drawdown, the Implementation of the Iraq Liberation Act, Confiscating and Vesting Certain Iraqi Property, an investigation into the fate of Commander Michael Scott Speicher, and post-combat plans for Iraq. There are also agendas, memoranda, reports, lists, and talking points outlining the objectives and topics covered at the 2001 G7/8 Summit sessions in Genoa, Italy and the 2002 APEC Leaders' Meeting in Los Cabos, Mexico; unclassified briefings with maps and charts; and FY2003 supplemental appropriations requests. In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to you, as former President George W. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the systematic processing projects described in Attachment A.

These records, consisting of 27,603 pages, have been reviewed for all applicable FOIA exemptions, resulting in 399 pages restricted in whole and 144 pages restricted in part. NARA is proposing to open the remaining 27,060 in whole and 144 pages in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is April 16, 2024, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
