STD NOT to be confused with separate DoD Directive 5015.2

- **1997 -- Set of Baseline Functional Requirements**
- 2001 -- Added Classified Records Metadata
- 2002 -- Version 2 last published
- 2003 -- NARA endorses the Federal-wide adoption of the DoD 5015.2-STD Version 2
- 2007 -- Version 3 added FOIA/Privacy Act and Basic Interoperability





What's New in Version 3?

- **FOIA/Privacy Act**
 - Additional Metadata, including email
 - Work flow, Alerts, and Response Timing Requirements
 - Builds on Automatic Linking, User Defined Fields and Logic from Ver 2
- Interoperability: Requires Tools to Support -
 - Data Discovery Standards, including email
 - NARA Record Archival Export Standards
 - Import/Export Standards for Moving Records among Compliant Electronic Recordkeeping Systems (EKMS)
- Encourages Solutions Such as SOA

From JITC: Of Note to Vendors

- Analyze new version completely
- Stay engaged
- Scripts are important
- Test cases are artificial scenarios
- JITC contracting process will change:
 - 3 Year Contract (1 yr coord; 2 yrs compliance)
 - Baseline fee \$30K; travel is additional
 - Fee paid incrementally; \$1000 to start
 - Must have signed contract to start test coordination
- Have three vendors willing to test under Version 3
 - First Version 3 test planned for January 2008
 - There are fifteen Version 2 tests to complete before that





Upcoming DoD CIO/IP Actions

- Will begin revision of the basic directive, DoDD 5015.2
- Will start draft of DoD 5015.2-STD, Version 4
- Focused education campaign for DoD users

Considerations for Version 4, **DoD-STD 5015.2**

- Archiving disposition determined at creation of record document
- Interoperability at both component and enterprise levels
- Metadata tagging capability for discovery


Net-Centric Data Strategy Highlights

- The Net-Centric Data Strategy (signed May 9, 2003) is a key enabler of the Department's transformation and outlines several goals including:
 - ✓ Ensuring data are visible, accessible, and understandable when needed and where needed to accelerate decision making
- The goals will be accomplished by:
 - \checkmark "Tagging" of all data (intelligence, non-intelligence, raw, and processed) with metadata to enable discovery by known and unanticipated users in the Enterprise
 - Posting of all data to shared spaces for users to access except when limited by security, policy, or regulations
 - Organizing around Communities of Interest (COIs)

DoDD 8320.2 (signed Dec 2, 2004) directs implementation of the Net-Centric Data Strategy. DoDD 8320.2 – G (signed April 12, 2006) provides guidance for implementing the **DoD Net-Centric Data Strategy.**
