Scope and Content

The materials in this series are responsive to the topic of FOIA request 2015-0031-F.

The metadata files contain information related to the photographs taken by David Bohrer on September 11, 2001 the White House maintained and turned over to NARA at the end of the George W. Bush Administration. The files are a compilation of the photograph-level metadata the White House Photograph Office created and maintained in its digital asset management system. The metadata for each photograph includes a unique system identifier, roll and frame numbers, date and location, and the photographer. There is also information related to White House Photo Office work processes such as the record code assignment, the photo credit, editorial rating, release information, oversized reproduction (i.e. jumbo) creation, and the list of projects which included individual photographs. There is also technical information about the photographs: width; height; and file names.

System of Arrangement

Records responsive to this FOIA request were found in the Vice Presidential images collection from the White House Photo Office. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President George W. Bush.

The individual metadata information for the 622 Vice Presidential photographs taken on September 11th are compiled into one spreadsheet. The spreadsheet includes three pages representing the three processing projects under which the photographs were reviewed for release by the Presidential Materials Division: FOIA 2014-0012 (September 11th); FOIA 2014-0012 (David Addington, Part 6); and 2015-0028-S.
