Access

Official records of the Richard Cheney vice presidency are in the custody of the Archival Operations Division in Washington, DC and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2022-0002-F.

This series consists of a May 1, 2001 briefing book and a scheduling binder for May 2001 for Vice President Cheney. The briefing book contains a barcode scanning cover sheet, draft schedule for May 1, 2001, tab dividers, meeting memoranda, talking points, news article printouts, a May monthly calendar and draft narrative schedules. The briefing book includes preparatory materials for Vice President Cheney's meeting with United States Representative Gary Condit, a meeting with California's Republican House delegation, and attendance at a Republican Senate policy lunch.

The May 2001 scheduling binder consists of draft schedules, schedule proposals, memoranda, letters, email printouts, calendars, invitations, handwritten notes, website printouts, fax cover sheets, tab dividers, website. The binder documents all Vice President Cheney's meetings and events held from May 1, 2001 through May 31, 2001. Within this time period Vice President Cheney met with a number of foreign officials including: Kazakhstan Foreign Minister Erlan Idrissov, Israeli Foreign Minister Shimon Peres, Amir of Bahrain Shaykh Hamad bin Issa Al-Khalifa, Prime Minister of Hungary Viktor Orban, Australian Defense Minister Peter Reith, Australian Foreign Minister Alexander Downer, Australia's Chief Minister of the Northern Territory Denis Burke, Yugoslavian President Vojislav Kostunica, Nigerian President Olusegun Obasanjo, Greek Foreign Minister George Papandreou and Israeli President Moshe Katzav.

Other individuals and groups that Vice President Cheney met with in May 2001 include: U.S. Ambassador to Oman John Craig; U.S. Ambassador to the United Nations John D. Negroponte; Supreme Court Justices Anthony Kennedy and Antonin Scalia; former U.S. Secretary of State General Alexander Haig, Senator Harry Reid; Senator Tom Daschle; Senator Byron Dorgan; U.S. Representative Darrell Issa; Virginia Governor Jim Gilmore; former First Deputy Prime Minister of Russia Anatoly Chubais; President and CEO of U.S. Chamber of Commerce Tom Donohue; CEO of Home Depot Bernie Marcus; CEO of General Motors Richard Wagoner, Jr.; President and CEO Colonial Pipeline David Lemmon; CEO of Halliburton David Laser; National Rifle Association (NRA) representatives Randy Scheunemann, Wayne LaPierre, James Jay Baker and Patrick O'Malley; President and Chairman of Export-Import Bank James Harmon; co-chair of President's Council of Advisors on Science and Technology (PCAST) Floyd Kvamme; Freedom House representatives; the U.S. Pan Asian American Chamber of Commerce; the Wyoming Wool Growers Association; the National Association of Manufacturers; the D.C. Echo Chamber Group; the Alliance of Automobile Manufacturers Board of Directors; and scholars Arthur Waldron and Aaron Friedberg.

In addition to meetings with Vice President Cheney, these scheduling records also document Vice President Cheney's attendance at various events. These events include: a Social Security Commission announcement, the Republican National Committee (RNC) Leadership Gala, a reception for Meg Greenfield, the Corcoran Gallery of Art reception and dinner in honor of Philip Anschutz, an Empower America Spring Conference dinner, a reception and dinner honoring Treasury Secretary O'Neill, the Nuclear Energy Institute's 2001 Nuclear Energy Assembly, a visit and ceremony at JY Ranch in Wyoming, a United States Air Force Academy commencement in Colorado, and a farewell ceremony for Office of the Vice President staff member LTC Richard Klumpp.

There are also letters, emails and fax coversheets proposing meetings with Vice President Cheney and interviews with various journalists regarding the administration's energy policy as well as photo opportunity requests by individuals, groups and families visiting the White House.
