These are organized in sub-folders based on the date opened. The purpose of these restricted CI folders on DTRANET-S is to establish a place of records for investigations that identify threats to DTRA operations posed by hostile organizations or internally by individuals engaged in espionage, sabotage, subversion, or terrorism. Information is collected, monitored, and analyzed pertaining to unusual or suspicious activities in an effort to protect the Agency's interests and equities in accordance with Department of Defense Counterintelligence Directives 5240.02, 5240.21. Documents may contain SSN, date and place of birth, address, full name, duty position, phone number, user profile for government systems, foreign travel (dates and locations) and security clearance level. The input of this information is limited to the Defense Threat Reduction Agency Counterintelligence Division consisting of approximately 70 individuals. PII access is routinely restricted to approximately 10 individual users with a strict Need to Know.
