The Commander's Risk Reduction Dashboard Increment II (CRRD INC II) is a web-based system (URL at: crrd2.army.mil) used by Command teams at each Army unit worldwide that does not provide public use. It replaces Commander's Risk Reduction Dashboard Increment I system. CRRD INC II is designed primarily to assist local Commanders to identify, and engage with, Soldiers associated with high-risk behaviors. The system has eleven interfaces with a variety of existing law enforcement, medical or behavioral diagnosis, substance abuse, family advocacy, financial assistance, and other systems in order to aggregate data, monitor trends, and track metrics. This data is analyzed for risk and predictive factors in order to identify at-risk Soldiers for intervention. Data received from each data source is either a total refresh or incremental data. Data is updated daily or weekly depending on the data source. Backups are performed daily local Veritas Net Backup software. This system contains records from 1 Oct 2008 to present. Input to this system is from Army and DoD systems, scanned anonymous surveys stored by United Identification Code, some dropdown or radio button entries by Command teams, and local POC information entered by local community administrators. The outputs to this system is Adhoc or specific real time Reports, Charts, Tables, and information screens. Input records covered by DAA-GRS-2013-0001-0001 Item 10 for hard copy and analog, and by DAA-GRS-2013-0001-0004 Item 20 for electronic input/source records. Output ad-hoc records are covered by DAA-GRS-2013-0001-0005 Item 30, and output data file records are covered by DAA-GRS-0001-0006 Item 31.
