**Background Information** 

#### **BACKGROUND:**

On October 1, 2013, the Department of Defense established the Defense Health Agency (DHA) to manage the activities of the Military Health System. These activities include those previously managed by TRICARE Management Activity (TMA), which was disestablished on the same date.

System Title: Transportation Command Regulating Command and Control Evacuation System (TRAC²ES); Its purpose is to provide automated capabilities to support patient movement Command and Control (C2), including Patient/Asset Visibility (P/AV). P/AV encompasses In-transit Visibility (ITV), as well as management of lift-bed resources and collaborative decision support for Patient Movement Requests (PMRs) and mission execution within (intra) and between (inter) theaters, commanded by geographic Commanders.

Inputs: System inputs include but are not limited to patient identity, service affiliation, grade or status, sex, medical diagnosis, medical condition, necessary special procedures or requirements, required medical specialties administrative considerations, personal

considerations, patient home address and/or duty station, and other information affecting the transfer on all active duty military personnel including the National Guard, Air National Guard, Reserves and Coast Guard.

The following are the specific record input capabilities for system users at MTFs and PMRCs:

- a. MTF patient movement requests, MTF information (medical treatment capabilities, patient accommodation capacity, contact information, etc.), and in-transit visibility (ITV) events (patient information, itinerary information, last reported location, etc.) for departing and arriving patients. Users at MTFs will have the ability to edit patient movement request records in the system. Users at MTFs only can access and edit records created by their respective MTF.
- b. PMRC approval of patient movement requests from MTFs, mission data (routes, timings, patient loads, etc.), special requirements for patient movement, and available lift capability (patient accommodation capacity in terms of transportation mode). System users at PMRCs will have the ability to edit patient movement requests in the system.

Outputs: Include but are not limited to ADHOC reports, audits logs (GRS 20 Item 5)
