1) **BACKGROUND:** The Foreign Disclosure System (FDS) is used by the Office of the Under Secretary of Defense for Policy (OUSD(P)) which is responsible for providing policy guidance and support to the Secretary of Defense, and the Department of Defense (DoD), in alignment with national security objectives. The FDS was created in accordance with the DoD Directive 5230.11, Disclosure of Classified Military Information to Foreign Governments and International Organizations. The FDS allows the DoD to process and record requests for the disclosure of classified military information to foreign governments and international organizations. Data in system dates from 1982 through the present.

The system operates at the SECRET level and supports approximately 500 users at 120 remote locations throughout the OSD, the military departments, defense agencies, and non-DoD activities. Requests from Foreign Governments and International Organizations are input into the FDS in both paper and electronic form. Data from the Foreign Visits System (FVS) is also transferred to the FDS if an FVS case is approved, closed and included a request for classified information. ~~The paper inputs from Foreign Governments and International Organizations are covered under GRS 20, Item 2a and electronic inputs are covered under GRS 20, Item 2c. The FVS is being scheduled separately. Outputs from this system consist solely of hardcopy tabulations or queries of the information residing in the master file and are disposable under GRS 20, Item 6.~~

FILE DESCRIPTION: Information collected to support the transfer of Classified Military Information and sensitive unclassified data. The system is used for the coordination, tracking, and maintenance of records regarding the release of Classified Military Information (CMI) to Foreign Governments and International Organizations, carries out responsibilities assigned by the NDP-1, and contains applicable classification/declassification information. Included are:

- 1 • Case number, requestor, requesting country, National Disclosure Policy (NDP) Category, reason for request, items requested, DoD recommendation for release of information.
- 2 • Data systems specifications, file specifications, codebooks, record layouts, user guides, output specifications, and final reports (regardless of medium) relating to a master file or data base.

DISPOSITION: PERMANENT. Transfer copy of system and related documentation dating 1982-2005 to NARA upon approval of this schedule. Thereafter, cutoff at the end of each calendar year and transfer pre-accessioning copy, with related documentation, to NARA every 2 years. Transfer of legal custody to take place when records are 25 years old, after declassification review.
