Components of the Casualty Program are Southeast Asia Casualty Data Base (SEACAS), Korean Conflict Casualty File-II (KCCF-II), and Worldwide Military Service Casualty Program (WWMSC). (The latter is submitted on a separate SF-115.) All casualties in the SEACAS and KCCF-II have been declared dead; therefore, the Privacy Act of 1974 does not apply to records of these systems. However, not all casualties in the WWMSC have been declared dead. The same cautions that must be exercised in handling material subject to the Privacy Act must be used in handling WWMSC records. There is no requirement to publish a system notice for WWMSC although it is a consolidation of the Services casualty systems, which are published Privacy Systems.
