Background Information

TSA's mission is to protect the nation's transportation systems to ensure freedom of movement for people and commerce. TSA aviation authorities extend to all passengers, regardless of citizenship, for both domestic and international flights, as well as individuals seeking to enter the sterile area of airports. As part of its efforts to secure aviation transportation, TSA also verifies passenger identities in order to grant access to airport sterile areas. The TSA Transportation Security Officer (TSO) performing Travel Document Checker (TDC) functions currently verifies identity at the checkpoint by manually validating the identity document and boarding pass presented by the passenger, comparing the photograph on a passenger's identity document to the passenger's face, and then comparing the document's biographic information to the biographic information on passenger's boarding pass. To improve the speed, efficiency, and security of TSA's identity verification process, TSA is exploring the use of biometric matching technologies, with a focus on facial modalities "as the primary means of identity verification for aviation security screening." For instance, TSA will use a self-service version of a Credential Authentication Technology (CAT) device equipped with a camera (CAT-2) to validate that the identity document presented by the passenger was authentic and to compare the passenger's live facial image against the image from the passenger's identity document.

TSA is utilizing biometrics at the checkpoint or bag drop location to verify identity by performing one of two methods:

(i) 1:1 matching – comparison of the real-time biometric (live photo) to the photograph on a passenger's identity document (reference photo)

(ii) 1:n identification – comparison of the real-time biometric (live photo) collected from the passenger to a biometric of the passenger already accessible by DHS (reference photo)

The data is maintained under authority provided by: Aviation and Transportation Security Act of 2001 (Pub. L. 107-71, § 109(a)(7) (Nov. 19, 2001)), codified at 49 U.S.C. § 114 note; 49 U.S.C. § 44901.

This records schedule is only intended to cover biometric and limited biographical data obtained from the passenger at the checkpoint or at a bag drop location. For passenger data collected during airline reservations, the Secure Flight records schedule (N1-560-08-003) should continue to be followed. Testing data obtained from the passenger is covered by TSA's Operational Integration record series N1-560-04-14, Item 2. Transactional and testing IT data is covered by GRS 3.1 Item 20 and GRS 3.1 Item 011.

1 Biometric Passenger Data

Biometric passenger data consists of physical characteristics like – but not limited to – fingerprint, iris patterns, or facial features that can be used to identify an individual through automated recognition. Use of the facial modality includes three types of photographs: one, live photo of passengers taken at the checkpoint; two, the scanned photograph from the identity document or electronic photograph from a digital ID, which that will be used as the reference photograph for 1:1 matching solution.

Use of the facial modality currently includes photographs (as stated in the overview). For 1:n identification, TSA will partner with CBP to leverage CBP's Traveler Verification Service (TVS) as the matching engine to compare the live photo to the reference photo. CBP will be staging the reference photos by pulling them from U.S. Government databases to which they have access. CBP purges all photos, regardless of immigration or citizenship status, from TVS within 12 hours. CBP is providing its TVS as a service to TSA and makes no further use of the data. TSA will delete passenger photographs from the technical infrastructure communicating with CBP TVS within 24 hours after a passenger's scheduled departure time.

For 1:n identification, biographical information also consists of an individual's passport number, passport country, and TSA PreCheck® enrollment (e.g. known traveler number).
