## **Reason for submission:**

- (1) This action provides the disposition of records managed in the Aviation Safety Communique (SAFECON), a previous unscheduled system, used for aviation mishap reporting for the Department of the Interior (DOI) agencies and the U.S. Forest Service.
- (2) This action also incorporates the series into the numbering pattern of the Office of the Secretary's new records schedule

**7558.5 Aviation Safety Communiqué (SAFECON).** The Aviation Safety Communiqué (SAFECON) database fulfills the Aviation Mishap Information System (AMIS) requirements for aviation mishap reporting for the Department of the Interior (DOI) agencies and the U.S. Forest Service. Categories of reports include airspace, incidents, hazards, maintenance, management and mishap prevention. The system uses the SAFECON Form AMD-34 or FS-5700-14 to report any condition, observation, act, maintenance problem, or circumstance with personnel or aircraft that has the potential to cause an aviation-related mishap. Data is stored in a central database that is shared on an interagency basis. The database is used as a tool to help identify, document, track and correct safety related issues. Data is also used to perform aircraft mishap trend analysis and develop statistical data for use in the Interior Aircraft Accident Prevention Program.

This disposition schedule only applies to Department of the Interior related data maintained in the SAFECON system.

Disposition: Temporary. Cut off at the end of the fiscal year following aircraft disposal or removal of related equipment from use by the Department of the Interior's aviation program; or after completion of an appropriate investigation and preparation of required reports. Destroy data 10 years after the cut off date.
