

INACTIVE - ALL ITEMS SUPERSEDED OR OBSOLETE

All items in this schedule are inactive. Items are either obsolete or have been superseded by newer NARA approved records schedules.

Description:

Items 23 and 24 were submitted because in 1981 GRS 4 items 2 (Property Disposal Case Files) and 3 (Excess Real Property Reports), originally scheduled for disposal in the first GRS in 1952, stated "Submit SF-115." These items were later restored to the GRS as disposable. N1-057-08-006, item 1005-04e, covers all records covered in NC1-057-81-04 items 23 and 24, and cites GRS 4, item 2 as its authority. This means USGS had, at some point between 1981 and 2008, abandoned items 23 and 24 in favor of using the GRS.

Item 25 was submitted in response to GRS 3, (1978 edition) item 1 (Unique Procurement Files), which simply instructed agencies to submit a SF-115 to schedule the records uniquely. This item was later dropped from the GRS. Since the disposition of item 25 matches the current GRS disposition for all procurement records (GRS 1.1, item 010), the need for USGS's unique item disappears. The item can be considered inactive.
