3	Daily Record of Arrival, Departure, and Absence of Employees, 1913-1917, 1 vol. A daily record showing the names of the employees, the time they arrived at work and the time of departure, and the days and hours absent.		
4	Records of Moneys Received and Disbursed for Night Service of Inspectors, 1911-1913, 1 vol. Describes type of service, lists the name of vessel to which service was rendered, the amount collected, who paid it, and the name of the customs officers paid.

	<p><u>Warehouse</u>, 1896-1917, 4 vols. Only a few pages in each volume. Information includes date of report, name of vessel and port, date of arrival, marks on goods, their number, quantity and description, from which warehouse received and date permitted.</p>		
6	<p><u>Warehouse Bonds</u>, 1867-1911, 4 vols. Legal documents whereby the principles and sureties bound themselves to pay a certain sum of money to the United States as a penalty if they fail to reexport merchandise which was imported duty-free and stored in the bonded warehouse or if they withdraw merchandise from warehouse for New London and fail to pay legitimate customs dues. This type of bond is sometimes referred to as a double or conditional bond.</p>		
7	<p><u>Exportation Bonds</u>, 1870-1884, 1917, 3 vols. Principles and sureties bound themselves to pay to the U.S. a certain sum of money as a penalty if they fail to carry out the agreement whereby the merchandise they imported duty-free and entered for warehousing in bond must be withdrawn from the warehouse and exported abroad. Attached to the bonds are certificate of the consignee and oaths of the masters and mates. The 1917 volume is empty except for one page.</p>		
8	<p><u>Transportation Bond</u>, 1870-1895, 1 vol. Principles and sureties bound themselves to pay to the U.S. a certain sum of money as a penalty if they fail to transport to another American port merchandise which was imported duty-free.</p>		
9	<p><u>Bond to Produce Certified Invoice</u>, 1908, 1916-1919, 2 vols. Principles bound themselves to pay a penalty to U.S. if they fail to produce to the Collector an authenticated invoice on the merchandise imported. 1908 volume is empty except for one page and the other is empty except for two pages.</p>		
9	<p><u>Special Bond for Lading or Unlading</u>, 1916, 1 vol. Only one page is used.</p>		
10	<p><u>Bond to Produce Verified Invoice</u>, 1888-1889, 1 vol. Only two pages used.</p>		
11	<p><u>Bond of Importer on Delivery of Packages not Designated for Examination</u>, 1888-1889, 1916, 2 vols. Only three pages used in the 1888-1889 volume and only 10</p>

Information includes the bond number, the date, the name of the importer, from where goods were imported, and description of merchandise.		
13	<u>Records of Bonds Filed in the District</u> , 1908-1917, 1 vol. Lists kind of bond, bond number, date of approval, names and residences of principles and sureties, penal sum of bond, value of property and remarks.		
14	<u>Register of Public Vouchers</u> , 1925-1926, 1 vol. Only one page. Shows name of payee, articles or labor furnished, date furnished, amount paid and remarks.		
15	<u>Bond of Masters for Entry of Cargoes in Other Ports</u> , 1871-1896, 1 vol. Masters bound themselves to pay a certain sum of money to the United States if they fail to re-export to other American ports merchandise which was imported duty-free.		
16	<u>Stonington Customs Records</u>  1. <u>Exportation Bonds</u> , 1874-1878 Principles and sureties bound themselves to pay to the United States a certain sum of money as a penalty if they fail to re-export merchandise imported duty-free and stored in bonded warehouse for re-exportation. Only a few pages used.  2. <u>Record of Account Current of Emoluments from Fees, Commission, Compensations, Fines and Penalties</u> , 1902-1905, 1 vol. Only a few pages occupied. Monthly account of emoluments from the above sources.  3. <u>Accounts Receivable-Stonington Lobster Co.</u> , 1929-1931 Lists credit and cash accounts, and expenses for such items as salaries, rents, coal, ice.
