This information was collected from April 7, 2017 until August 7, 2017 and stored in a database. The database is used by Spectrum access system (SAS) administrators to establish these legacy Wireless Protection Zones around incumbent operations in the 3650 MHz service and protect them from new CBRS operations until the end of the CBRS transition October 17, 2020 for most licensees, but as late as January 8, 2023 for some licenses with later expiration dates. These files also contain an annual report which is provided to the SAS that identifies all protected licenses cancelled, expired, or otherwise removed for the database in the previous year. |
