The Committee was responsible for monitoring implementation of the government's nondiscrimination policy in Executive branch agency hiring and contract letting. The Committee was abolished by EO 11246 of September 24, 1965, effective October 24, 1965, with residual matters transferred for resolution, as appropriate, to the Department of Labor and the Civil Service Commission.
