Description:

The Lower Mississippi Delta Development Commission was established by an act of October 1, 1988 (102 Stat. 229), to identify economic, environmental, educational, medical, and other social needs of the Lower Mississippi Delta region (comprised of 219 counties and parishes in Arkansas, Illinois, Kentucky, Louisiana, Mississippi, Missouri, and Tennessee), and to establish priorities for their fulfillment. The Commission terminated on September 30, 1990.



	<p>The Lower Mississippi Delta Development Commission was established under Public Law 100-460 in October 1988 through legislation introduced by a bi-partisan group of senators and representatives from the seven states making up the Lower Mississippi Delta region, as well as Congressmen from other parts of the nation. The Lower Mississippi Delta area was originally comprised of 214 counties and parishes in Arkansas, Illinois, Kentucky, Louisiana, Mississippi, Missouri, and Tennessee, and was later modified to include an additional five parishes in the state of Louisiana. The Commission was established to study and make recommendations regarding economic needs, problems, and opportunities in the Delta, and to develop a ten-year regional economic development plan. The Commission held public hearings in each of the seven states, sponsored several different conferences on a variety of topics, and solicited research from citizens and organizations. The Commission issued an Interim Report in October 1989 and a Final Report in May 1990.</p>		
1.	<p>Research Contracts/Conferences The Commission, in conjunction with a variety of groups and organizations, sponsored nine conferences which covered topics such as Education, Community Action Organizations, Economics, Energy, and the Environment, The Role of Churches in Economic Development, Agriculture, Poverty, Housing, and Leadership. In addition, the Commission granted 26 research contracts which covered a wide variety of subjects such as: Infrastructure, Telecommunications, Housing, Public Management Expertise, Value-Added Industries, Labor Markets,</p>

Records are arranged alphabetically by state.
