Described below are all remaining unscheduled records assigned to RG 234 at the Washington National Records Center. Often intermingled with the permanent records are disposable materials which cannot easily be removed until the records are transferred to the National Archives where they can be screened during archival processing. In addition to those records identified in this schedule, the National Archives will remove records authorized for destruction under the following:

Price Adjustment Board

1. Chronological Files, 1942-53 2 cu. ft. Arranged numerically by PAB agreement number, 1-700.

Contract renegotiation agreements between the PAB and its contractors to eliminate excessive profits pursuant to the Renegotiation Act of 1942. Contractors were hired to meet the needs of the U.S. wartime production efforts.

Correspondence, transcripts, memoranda, lists, and circulars concerning decisions and actions of the PAB regarding renegotiated contracts with contractors and subsidiaries, including records relating to clearances given to contractors and subsidiaries upon elimination or reduction of excessive profits or charges made to the PAB.

War Damage Corporation

3. Correspondence, 1942-58. 1 cu. ft. Arranged by type of record or by name of company.

Miscellaneous correspondence, photostatic copies of correspondence, memoranda, and index cards relating to claims files with the War Damage Corporation due to damages sustained to property during World War II. Property damages were reported in the Philippines, Wake Island, and Guam.

4. Bonds and Loyalty Case Files, 1938-50. 1 cu. ft. Arranged by type of record or by name of company.

Memoranda, bond cancellation agreements, and correspondence relating to the bonding of employees in various metal or chemical companies. Most of the bonds were issued by the Maryland Casualty Company. Other bonds issued covered indemnity and surety. Also included are files relating to "loyalty" background investigations of RFC employees.
