1.	<p><u>File #:</u> 703-04, AR 340-18-7.  <u>Title:</u> ROTC SCHOLARSHIP NONSELECTED APPLICANT FILES.  <u>Description:</u> No change.  <u>Disposition:</u> Change to read, "Destroy 1 year after graduation of the non-selectee's class."  <u>Background:</u> The current disposition, "Destroy after 5 years," was written when only 4-year scholarships were awarded for Army ROTC; however, 1-, 2-, and 3-year scholarships are also available now. The retention period allows for research into reclaims and congressional inquiries initiated by those not selected for ROTC scholarships. However, once an individual (or his or her class) has graduated from the institution, there is no further basis for reclaim. The new disposition proposed above allows the record to be destroyed 1 year after the class graduation regardless of the length of scholarship assistance that was initially sought by the individual applicant.</p>
