I, FURTHER CERTIFY, That the following is a result of the canvass made and certified by the State Board of Canvassers pursuant to law, showing the whole number of votes cast at said election for each person for whose appointment any and all votes were cast for the office of Electors of President and Vice President of the United States, viz.:

The Electors on the Republican Ticket were: Travis Hawkes, Meridian, Idaho, Teresa Luna, Boise, Idaho, Jason Risch, Boise, Idaho and Damond Watkins, Idaho Falls, Idaho. Each of them received Four Hundred Twenty Thousand Nine Hundred and Eleven (420,911) votes.

The Electors on the Democratic Ticket were: David Bieter, Boise, Idaho, Bethine Church, Boise, Idaho, Marilyn Howard, Boise, Idaho and George Millward, Pocatello, Idaho. Each of them received Two Hundred Twelve Thousand Seven Hundred Eighty Seven (212,787) votes.

The Electors on the Constitution Ticket were: Daniel Brannan, Coeur d'Alene, Idaho, David Hay, Ammon, Idaho, Paul Venable, Parma, Idaho and Floyd Whitley, Cottonwood, Idaho. Each of them received Two Thousand Two Hundred Twenty Two (2,222) votes.

The Electors on the Independent Ticket for Jill Stein were: Robert Loftus, Moscow, Idaho, Eric Richardson, Nampa, Idaho, Caleb Thom, Boise, Idaho and Marlana Warner, Eagle, Idaho. Each of them received Four Thousand Four Hundred and Two (4,402) votes.

The Electors on the Independent Ticket for Ross C. "Rocky" Anderson were: Ciarran Camille Burch, Boise, Idaho, Colin Nathaniel Burch, Boise, Idaho, Calvin Leman, Salmon, Idaho and Matthew Alex Neiwirth, Boise, Idaho. Each of them received Two Thousand Four Hundred Ninety Nine (2,499) votes.
