Series Title: Records of the Alaska Matanuska Colony

General Notes: In 1999, these records were physically transferred from Alaska Pacific University. Names in this list were taken from the folder titles, and there may be inconsistencies in spelling. Records are in original order; researchers will not find all of a family's records in one location.

Series Description: These records were created by the Alaska Rural Rehabilitation Corporation of the US Federal Emergency Relief Administration (FERA). The records relate to the rural rehabilitation activities of the FERA and are part of the WPA record group. The Matanuska Colony Project was a New Deal Project in which families from Wisconsin, Minnesota and Chicago, IL settled into the Matanuska Valley and Palmer.

This series consist of material regarding administrative organization, applications for admission, colonist relations, land records, reports, financial documentation, and community activities. Of particular interest to researchers are records regarding buildings and grounds, applications for admission, land titles and leases, and survey information.
