THE DECORATIONS TO BE CONFERRED ARE (1) "MUERTO HEROICAMENTE EN COMBATE" (HEROICALLY KILLED IN COMBAT), AND (2) "CONDECORACION ORDEN DE MAYO AL MERITO MILITAR EN EL GRADO DE GRAN CRUZ" (ORDER OF MAY FOR MILITARY MERIT, IN THE GRADE OF GREAT CROSS).

2. (C) A FIELD TRANSLATION OF THE ARGENTINE ARMY DOCUMENT AUTHORIZING THE "HEROICALLY KILLED IN COMBAT" MEDAL FOLLOWS:

BUENOS AIRES 26 OCTOBER OF 1981

THAT, DUE TO THE CLOSE RELATION OF OUR ARMY WITH THE ARMY OF THE UNITED STATES, THE ARGENTINE ARMY FINDS IT ADVISABLE TO MANIFEST ITS OBJECTIVES ON AN INTERNATIONAL LEVEL, WITH FIRM SUPPORT FOR THE CHRISTIAN CONCEPT OF FREEDOM.

THAT, FOR ALL PREVIOUSLY STATED, THE ARGENTINE ARMY UNDERSTANDS THAT WITH THE RESPECT RENDERED, IT IS GIVING AN AUTHENTIC EXPRESSION THE SOLIDARITY TO THOSE WHICH FOUGHT WITH COURAGE, LOSING THEIR LIVES, ON BEHALF OF THE NOBLE AND GOOD REASONS THAT SERVE AS A BASIS FOR OUR NATIONALITY.

1. Purpose: To obtain CSA signature on letter of invitation to Lieutenant General Galtieri for a weekend at USMA. Also to inform CSA status of proposed visit of General Marques, Brazilian C/S.
2. Discussion:
 - a. Colonel Jack Smith, USARMA, Buenos Aires, has responded positively to a feasibility inquiry for Lieutenant General Galtieri to visit West Point 6 - 9 November. The visit would be conducted under the auspices of CSA counterpart program, and would include briefings, a tour, and the Army/Holy Cross football game.
 - b. Colonel James Powell, USARMA, Brazilia, met with General Marques to discuss proposed CSA counterpart visit. ~~General Marques explained to Colonel Powell that Mrs. Marques has convinced him to decline any official invitation to visit the US Army upon completion of the CIA. General and Mrs. Marques will remain in CONUS on an unofficial weekend. I have asked Colonel Powell to check on feasibility of General and Mrs. Marques visiting USMA only, as your guests. General Marques has yet to respond.~~
