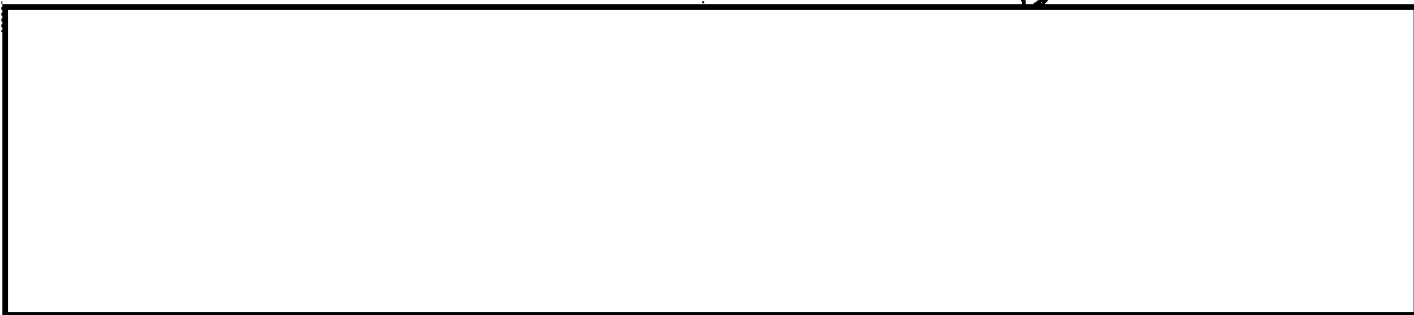

THE LIST EXCLUDES THE PERIOD AROUND 26 JULY 1975, THE ANNIVERSARY OF THE DEATH OF EVITA PERON. THE NUMEROUS INCIDENTS DURING THE 26 JULY PERIOD HAVE BEEN DEALT WITH SEPARATELY [REDACTED] MOST OF THE INCIDENTS INVOLVE BOMB EXPLOSIONS, THEFT OF WEAPONS, SOME SHOOTINGS AND KILLING, AND DISTRIBUTION OF SUBVERSIVE PROPAGANDA.

ORDERS TO KILL THE COUPLE WERE TO BE CARRIED OUT ON 2 AUGUST 1975. IT WAS DECIDED THAT THE LIFE OF POGGIOLI WOULD BE SPARED AS HE KNEW NOTHING ABOUT BADUAN.

5. THE POLICE ARE NOW DELAYING FURTHER IMPLEMENTATION OF THE PLAN AGAINST ERP MEMBERS TO ASCERTAIN WHETHER THERE ARE ANY REPERCUSSIONS FROM THE POGGIOLI/"CESAR" INCIDENT. ALTHOUGH THE POLICE HAD RECENTLY RECEIVED INSTRUCTIONS TO MAKE ALL POLICE OPERATIONS LEGAL, THE DECISION TO KILL "CESAR" AND HIS WIFE WAS CONSIDERED NECESSARY TO SAVE THE LIFE OF BADUAN. WITHIN THE POLICE THERE IS UNEASINESS AS TO WHO ELSE AMONG THEM MAY BE A TARGET OF THE ERP.

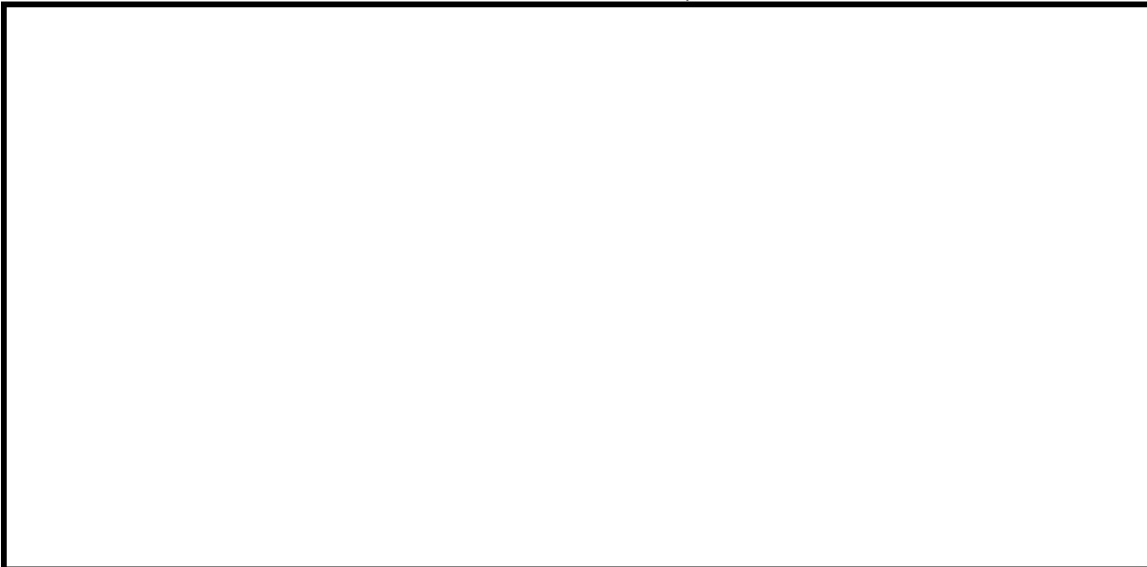

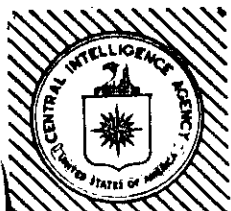
