
DEGREE OF DISSENSION CURRENTLY EXISTS WITHIN THE ARMY, BUT HE SAID HE DOES NOT REGARD IT TO BE EXTENSIVE NOR A THREAT TO HIS AUTHORITY. VIDELA SAID THAT HE BELIEVES THAT AS LONG AS A CRISIS SITUATION EXISTS, WHICH IS THE CASE AT PRESENT, PARTICULARLY IN THE ECONOMIC SPHERE, THERE WILL BE FEW OFFICERS, IF ANY, IN THE OPPOSITION ASPIRING TO HIS JOB. HOWEVER, ONCE THE CRISIS PERIOD ABATES, VIDELA SAID HE EXPECTS A MOVE COULD THEN CONCEIVABLY BE MADE TO OVERTHROW HIM. TO HELP PREVENT THIS POSSIBILITY, VIDELA STATED THAT HE WILL PROBABLY HAVE TO SHUFFLE OFFICERS AROUND BEFORE THE END OF THE YEAR TO REMOVE POTENTIALLY PROBLEM OFFICERS FROM STRATEGIC POSITIONS.




