LEADER OF THE MONTONERO GUERRILLA ORGANIZATION, WAS PICKED UP ON A BEACH IN MARTINEZ, BUENOS AIRES PROVINCE, BY INDIVIDUALS WHO IDENTIFIED THEMSELVES AS OFFICERS OF THE FEDERAL POLICE OF ARGENTINA (FPA). SUBSEQUENT INQUIRIES BY QUIETO'S RELATIVES, WHICH WERE PUBLISHED IN THE BUENOS AIRES NEWS MEDIA, INDICATED THAT THE FPA, THE BUENOS AIRES PROVINCIAL POLICE, THE ARGENTINE ARMY AND OTHER ARGENTINE GOVERNMENT ENTITIES STEADFASTLY DENIED THAT QUIETO WAS IN CUSTODY.
