We have Legal Attache and two stenographers assigned at U. S. Embassy, BA. Chile and Uruguay are covered by Legat, BA. [Redacted]

Attached, from American Embassy, BA, indicates on 9/20/76 a Ford motor company security officer in BA advised the Embassy that at 5:35 a.m. on 9/15/76 a pick-up truck stopped in front of the garage at the home of a Ford motor company staff manager. Approximately 100 rounds were fired from a machine gun. Guards at the garage returned fire.

As the truck fled the scene, propaganda (pamphlets) were thrown from the vehicle. The propaganda claimed "military assassins" and employers were exploiting the people and the "Montonero resistance will win." (A similar attack took place 3/26/76 during which guards were killed at the same residence.)

On 9/20/76 at 5:00 a.m. shots were also fired from a truck at the windows of a building housing Chrysler administrative offices in BA. Same type machine gun was used and a communique was left identifying the attacking group as Montoneros. Also on 9/20/76 an Argentine citizen who was Deputy Chief of the Schering Pharmaceutical Company was assassinated at point blank range by two individuals while he was waiting for a bus, to go to work, at a street corner in a suburb of BA.

The Embassy noted during the period 1/1/76 - 8/31/76, 14 non-U. S. citizens, senior executives, of major companies have been victims of terrorist attacks. Those assassinated were employed by Bendix, Swift, Chrysler, Fiat, etc. Embassy also noted Legat stated that in last 20 days two Chrysler officials resigned and a third executive was removed to Sao Paulo for his protection. Embassy stated in addition to assassinations, 14 Argentine nationals in management positions in U. S. companies have been kidnapped and released for ransom; held, interrogated and released without ransom; or, whereabouts remain unknown.

1. ON SEPT. 20, THE SECURITY OFFICER, FORD MOTOR CO., ADVISED THE RSO OF THE FOLLOWING. AT APPROXIMATELY 0535 HRS ON SEPT 15, A RED CHEVROLET PICKUP TRUCK STOPPED IN FRONT OF THE GARAGE OF THE HOME OF ING. ~~JORGE N. PAQUET~~, MANUFACTURING AND PLANT ENGINEERING STAFF MANAGER, LOCATED AT JORGE NEWBERRY 1321, HURLINGHAM. APPROXIMATELY 100 ROUNDS WERE FIRED FROM A FAL MACHINE GUN <sup>AA9</sup> (7.62 MM). THE GUARDS, WHO WERE LOCATED IN THE GARAGE, RETURNED FIRE WITH AN ITACA MACHINE GUN (9 MM). THE PICKUP DEPARTED THE AREA AND PAMPHLETS WERE THROWN FROM THE VEHICLE. ONE OF THE PAMPHLETS HAS BEEN TRANSLATED, THE BODY OF WHICH IS QUOTED HEREWITH: "IN SIX MONTHS OF MILITARY DICTATORSHIP - SUSPENSION OF SALARY INCREASES - MASSIVE FIRING OF PERSONNEL - UNEMPLOYMENT - HUNGER SALARIES - FREE PRICE INCREASES - REPRESSION AGAINST WORKERS AND DELEGATES - 500 RECOGNIZED MURDERS - 5,000 KIDNAPPED AND TORTURED - 10,000 POLITICAL AND UNION PRISONERS - AGAINST THE DICTATORSHIP OF THE EXPLOITING EMPLOYERS AND MILITARY ASSASSINS, THE PEOPLE OPPOSE THEIR ORGANIZED STRENGTH. MONTONERO RESISTANCE WILL WIN." AN ATTACK SIMILAR TO THE ONE DESCRIBED ABOVE TOOK PLACE ON MARCH 26, 1976 DURING THE COURSE OF WHICH THE GUARDS ON MR. PAQUET'S HOUSE WERE KILLED.

2. LEGATT INFORMED THE RDO THAT THE MANAGING DIRECTOR OF THE CHRYSLER CORP. HAD ADVISED HIM ON SEPT. 20 THAT ON THAT SAME DATE, AT 0500 HRS, A GROUP OF ARMED INDIVIDUALS STOPPED IN FRONT OF THE CHRYSLER FEBRE-ARGENTINA ADMINISTRATIVE OFFICES IN SAN JUSTO, BUENOS AIRES PROVINCE. THE INDIVIDUALS IN THE TRUCK FIRED ON THE OFFICE BUILDING, RIDDLING THE WINDOWS OF THE CONFERENCE ROOM WITH ONE ROUND PASSING INTO THE OFFICE OF THE MANAGER/DIRECTOR. A SY GUARD RECOVERED A SPENT SHELL CASING WHICH IDENTIFIED ONE OF THE WEAPONS FIRED AS A FAL. A COMMUNIQUE WAS LEFT IDENTIFYING THE ATTACKING GROUP AS MONTONEROS.

3. ON SEPT. 20, ~~JOHN G. LITTLE~~, <sup>deceased</sup> (ARGENTINA CITIZEN) <sup>APPROX 1943</sup> DEPT. CHIEF, SCHERING PHARMACEUTICAL CO., WAS ASSASSINATED AT THE CORNER OF VIDAL AND SUCRE, BELGRANO, SUBURB OF BUENOS AIRES. MR. LITTLE, 33 YEARS OLD, WAS WAITING FOR A BUS TO TRAVEL TO HIS OFFICE, LOCATED AT THE SCHERING PLANT IN LOMAS DEL MIRADOR. LITTLE WAS SHOT AT POINTBLANK RANGE BY TWO INDIVIDUALS WHO FIRED AT HIM FROM THE STREET.

4. RSO COUNTER-TERRORIST ACTIONS IN ARGENTINA BETWEEN 1 JAN AND 31 AUG 76 (BA 6078). A COUNT IS NOT CURRENTLY AVAILABLE FOR THE MONTH OF SEPT TO DATE. IT IS SIGNIFICANT TO NOTE THAT OF THIS NUMBER, SOME 14 SENIOR EXECUTIVES, NON-U.S. CITIZENS, OF MAJOR COMPANIES HAVE BEEN VICTIMS. THIS DOES NOT INCLUDE THE LITTLE ASSASSINATION DESCRIBED ABOVE. THOSE ASSASSINATED HAVE BEEN EMPLOYED BY BENDIX, SWIFT, CHRYSLER, FIAT, ETC. LEGATT HAS ADVISED THAT IN THE LAST 20 DAYS THE PUBLIC RELATIONS DIRECTOR AND THE MANAGER OF MANUFACTURING AND ENGINEERING FOR THE CHRYSLER CORP. HAVE RESIGNED AND THAT A THIRD EXECUTIVE WHO WAS REMOVED TO SAO PAULO FOR HIS PROTECTION IS BECOMING DISCOURAGED AND CONSIDERING TERMINATING HIS EMPLOYMENT.

5. IN ADDITION TO ASSASSINATIONS, 14 ARGENTINE NATIONALS IN MANAGEMENT POSITIONS IN THE U.S. COMPANIES HAVE BEEN KIDNAPPED AND RELEASED FOR RANSOM; HELD, INTERROGATED AND RELEASED WITHOUT RANSOM, OR WHOSE WHEREABOUTS REMAIN UNREPORTED.

6. THE ATTACKS ON THE ARGENTINE EXECUTIVE OF U.S. AND OTHER COMPANIES APPEAR TO SUPPORT THE PREMISE THAT THE MONTONEROS ARE CARRYING OUT REVENGE OPERATIONS AGAINST COMPANIES FOR

THE ANALYSIS

REVEALS THAT THE MONTONEROS HAVE THE CAPABILITY TO ELECTRONICALLY INTERCEPT COMMUNICATIONS ON VERY HIGH FREQUENCY (VHF) NETWORKS, SUCH AS THOSE USED BY THE OFFICE OF THE PRESIDENCY, FEDERAL POLICE AND THE FEDERAL PENITENTIARY SERVICE. IN ADDITION, SOME FREQUENCIES USED BY THE ARGENTINE ARMY, NAVY AND AIR FORCE HAVE BEEN IDENTIFIED BY THE MONTONEROS. THE MONTONEROS ALSO ARE EQUIPPED WITH PORTABLE TWO-WAY RADIOS AND HAVE COMPATIBLE TWO-WAY RADIOS IN AUTOMOBILES AND CERTAIN BASE STATIONS.

GENERAL JOSE VILLARREAL

SECRETARY GENERAL OF THE PRESIDENCY, REFERRED TO DIFFERENCES WITHIN THE MILITARY AND SAID THAT "THERE ARE SERIOUS MOMENTS BUT IN MOST CASES THINGS ARE BEING WORKED OUT; SOME IMPORTANT DETAILS REMAIN, HOWEVER". VILLARREAL STATED THAT THE MOST SERIOUS DIFFERENCE IS THE POSITION WHICH SHOULD BE TAKEN WITH RESPECT TO THE LABOR UNIONS.

ACCORDING TO VILLARREAL, AN IMPORTANT PART OF THE NAVY AND SOME SECTORS OF THE ARMY OPPOSE FREEDOM OF THE UNIONS AND FAVOR DISSIPATING THE POWER OF LABOR BY DIVIDING THE GENERAL LABOR CONFEDERATION (CGT) INTO VARIOUS SMALL ORGANIZATIONS. BY CONTRAST, GENERAL ROBERTO ~~V~~ I O L A, CHIEF OF THE ARMY GENERAL STAFF, SUPPORTS THE CONTINUANCE OF A SINGLE CGT. VILLARREAL ASSERTED THAT HE IS IN AGREEMENT WITH VIOLA'S POSITION, COMMENTING THAT SEVERAL LABOR CONFEDERATIONS PROVIDE THE REPRESENTATIVE FACTORY COMMISSIONS WITH GREATER POTENTIAL POWER AND OPPORTUNITY FOR SUBVERSIVE CONTROL THAN WOULD BE THE CASE WITH ONE LARGE CGT IN WHICH THE IMPACT OF A SINGLE FACTORY IS DILUTED. VILLARREAL CONTINUED THAT SOME MILITARY ELEMENTS WANT TO COMPLETELY IGNORE TRADITIONAL PERONIST LABOR OFFICIALS IN THE REORGANIZATION OF THE UNION STRUCTURE. HOWEVER, VILLARREAL SAID HE FAVORS USING THOSE PERONIST LABOR LEADERS WHO ARE RELATIVELY UNTAINTED, TAKING ADVANTAGE OF THEIR KNOWLEDGE AND EXPERIENCE IN THE LABOR AREA, AS WELL AS THEIR INFLUENCE WITH THE WORKER RANK AND FILE, AND THEN IN EFFECT DISCARDING THESE


