

FURTHER DISSEMINATION AND USE OF THIS INFORMATION SUBJECT TO CONTROLS STATED AT BEGINNING AND END OF REPORT.

EMBASSY OFFICIALS NOW TEND TO BELIEVE THAT THE TWO CUBANS MAY WELL HAVE BEEN SEIZED BY AN ARGENTINE RIGHTIST GROUP, WHICH WANTED TO CREATE DIFFICULTIES FOR THE ARGENTINE GOVERNMENT. [Redacted]

THE RIGHTIST GROUP, WHILE POSSIBLY OFFICIALLY CONNECTED, MAY NONETHELESS BE OPPOSED TO POLICIES OF THE ARGENTINE GOVERNMENT, AND THEREFORE KIDNAPPED THE CUBANS TO CAUSE DIPLOMATIC PROBLEMS FOR THE ARGENTINE GOVERNMENT BY BRINGING ABOUT FRICTION BETWEEN CUBA AND ARGENTINA.

[Redacted] CUBAN EMBASSY OFFICIALS BELIEVE THE TWO CUBANS ARE ALIVE BUT THAT THEY HAVE PROBABLY BEEN ROUGHED UP AND WILL BE SET FREE WHEN THEY ARE IN BETTER CONDITION. [Redacted]

THE CUBAN AMBASSADOR CONSIDERS THE INCIDENT TO BE SERIOUS AND HOLDS THE ARGENTINE GOVERNMENT ULTIMATELY RESPONSIBLE FOR THE RELEASE OF THE TWO CUBANS. THE AMBASSADOR HAS ASSERTED THAT IF THE TWO CUBAN EMPLOYEES DO NOT APPEAR ALIVE AND WELL, A BREAK IN COMMERCIAL RELATIONS BETWEEN CUBA AND ARGENTINA COULD WELL OCCUR. [Redacted] REPORTS ALLEGING THE DEFECTION OF THE TWO CUBANS WERE COMPLETELY FALSE, AS THERE WERE WITNESSES TO THEIR HAVING BEEN FORCEFULLY TAKEN.

2. [Redacted] A FEW DAYS PRIOR TO THE DISAPPEARANCE OF THE CUBANS, AN ARGENTINE MAID OF A CUBAN OFFICIAL DISAPPEARED.



FURTHER DISSEMINATION AND USE OF THIS INFORMATION SUBJECT TO CONTROLS STATED AT BEGINNING AND END OF REPORT.

[REDACTED] WHICH DISCUSSES THE LEFTIST SUBVERSIVE SITUATION FOR THE PERIOD 19-26 AUGUST 1976. ACCORDING TO THIS REPORT, THE MONTONEROS HELD A PRESS CONFERENCE ON 19 AUGUST 1976 OF FOREIGN CORRESPONDENTS IN ARGENTINA IN WHICH THE MONTONERO REPRESENTATIVES INFORMED THE PARTICIPANTS THAT IN THE FORESEEABLE FUTURE THE MONTONEROS WOULD BE CONCENTRATING ON PROPAGANDA/PSYCHOLOGICAL OPERATIONS WITH LESS ATTENTION DIRECTED AT MILITANT ACTIVITIES. THE MONTONEROS ASSURED THAT THEY WOULD CONTINUE THE STRUGGLE, BUT THAT THE ORGANIZATION WAS IN NO HURRY AND WOULD WORK BEHIND THE SCENES TO GRADUALLY STRENGTHEN ITS SUPPORT. THE MONTONEROS STATED THAT AS A RESULT OF THE "PLAN OF HUNGER, GRIEF AND UNEMPLOYMENT" OF JOSE MARTINEZ DE HOZ, MINISTER OF ECONOMY, CONDITIONS WERE SUCH THAT PROPAGANDA/PSYCHOLOGICAL ACTIVITIES WERE TACTICALLY THE APPROPRIATE COURSE AT PRESENT FOR THE MONTONEROS TO PURSUE, AND NOT GREAT MILITARY OPERATIONS.

TACTIC. HOWEVER, [Redacted] THIS COURSE MAY HAVE BEEN ADOPTED BY THE MONTONEROS BECAUSE OF THE LOSSES, PARTICULARLY IN ITS LOGISTIC APPARATUS, WHICH THE MONTONEROS HAVE SUFFERED, AS WELL AS A LOWERING OF MORALE AMONG THE RANKS AS A RESULT OF THE COUNTERSUBVERSIVE CAMPAIGN.

ACCEPTED, HE WAS ADVISED THAT HE MUST OBEY IN DETAIL A SERIES OF SECURITY MEASURES OR HE WOULD BE KILLED. THE MONTONEROS THEN MADE A SECOND CALL TO THE CORRESPONDENT AT A PHONE NUMBER PROVIDED BY THE LATTER DURING THE FIRST CONVERSATION. THIS SECOND CALL TOOK PLACE SHORTLY BEFORE THE PRESS CONFERENCE WAS HELD, AND THE CORRESPONDENT WAS GIVEN INSTRUCTIONS FOR ATTENDING THE CONFERENCE. THE CORRESPONDENT WAS TOLD TO GO TO A SPECIFIC AREA ON A DESIGNATED STREET AND CARRY A FOLDED MAGAZINE IN HIS LEFT HAND. PER PREARRANGEMENT, A PERSON APPROACHED AND ASKED THE CORRESPONDENT FOR THE TIME. THE LATTER STATED A TIME MORE OR LESS AN HOUR AHEAD OF WHAT WAS THE ACTUAL TIME, AND THE MONTONERO RESPONDED WITH THE COUNTERSIGN "ALL RIGHT". THE CORRESPONDENT WAS THEN TAKEN TO A NEARBY AUTOMOBILE AND WAS TRANSPORTED BLINDFOLDED TO THE SITE OF THE PRESS CONFERENCE. THE PRESS CONFERENCE WAS ATTENDED BY ABOUT TEN MONTONEROS AND TOOK PLACE AT A PRIVATE HOME IN THE VILLA DEL PARQUE SECTION OF THE FEDERAL CAPITAL. NEITHER THE NUMBER NOR IDENTITY OF THE CORRESPONDENTS WHO ATTENDED IS KNOWN

4. OTHER THAN THE MONTONERO PRESS CONFERENCE, THE [REDACTED] OVERALL LEFTIST SUBVERSIVE ACTIVITY DURING THE 19-26 AUGUST PERIOD REMAINED AT ABOUT THE SAME LEVEL AS THE PREVIOUS PERIOD. [REDACTED] THE "GUEVARIST YOUTH", WHICH IS THE YOUTH ELEMENT OF THE "PEOPLE'S REVOLUTIONARY ARMY/REVOLUTIONARY WORKERS PARTY" (ERP/PRT), CONTINUED AS IN PREVIOUS WEEKS WITH A PROPAGANDA CAMPAIGN, PARTICULARLY IN THE LA PLATA, BUENOS AIRES PROVINCE, [REDACTED] POSSIBILITY THAT THE "GUEVARIST YOUTH" MAY ATTEMPT TO CONSOLIDATE AND BECOME THE FOREFRONT OF THE REMNANTS OF THE ERP/PRT. [REDACTED] IN A RECENT ISSUE OF "EL COMBATIENTE", THE OFFICIAL PUBLICATION OF THE PRT, THE PRT STATES THAT THUS FAR THE SUBVERSIVE STRUGGLE OF THE ERP/PRT HAS BEEN DEVELOPED ON THREE PILLARS--A MARXIST-LENINIST POLITICAL PARTY TO COORDINATE AND DIRECT THE ACTIVITIES OF THE PEOPLE, A POPULAR GUERRILLA ARMY AND A NATIONAL LIBERATION FRONT.
