THE RECENT ACTIONS BY THE SECURITY FORCES AGAINST THE MONTONEROS REPRESENT THE GREATEST BLOW EVER DEALT TO THE LOGISTICAL INFRASTRUCTURE OF A SUBVERSIVE ORGANIZATION IN ARGENTINA.



AS A RESULT OF THE RAIDS AGAINST MONTONERO WEAPONS FACTORIES AND SUPPLY CENTERS, THE AUTHORITIES CONFISCATED ALMOST ALL OF THE G-70 "ENERGA" GRENADES MADE BY THE MONTONEROS AND ALMOST ALL OF THE 16-22-MP GRENADE LAUNCHERS. IN ADDITION, ABOUT ONE-FOURTH OF THE HAND GRENADES UNDER PRODUCTION WERE SEIZED, AS WERE THE PROTOTYPES FOR 60 MM MORTARS.

SUMMARY: THE MAIN PURPOSE OF THE NATIONAL INTELLIGENCE CENTER (NIC) IS TO DEVELOP AND CONSOLIDATE INFORMATION ON THE VARIOUS LEFTIST TERRORIST GROUPS. THE TASK IS PRIMARILY CARRIED OUT BY ANALYZING CONFISCATED DOCUMENTS AND DATA PROVIDED BY CAPTURED SUBVERSIVES. THE NIC WORKS IN CONJUNCTION WITH MILITARY AND POLICE INTELLIGENCE UNITS, THE STATE INTELLIGENCE SECRETARIAT (SIDE) AND THE PENITENTIARY INTELLIGENCE SERVICE. THE NIC COMES UNDER THE COMMAND OF THE ARMY AND IS UNDER THE IMMEDIATE AUTHORITY OF THE ARMY 601ST INTELLIGENCE BATTALION.

THE NIC OCCASIONALLY PARTICIPATES IN SOME ACTION OPERATIONS CONDUCTED BY ONE OF THE SECURITY SERVICES. NIC ACTION OPERATIONS FALL WITHIN THE JURISDICTION OF THE ARMY FIRST CORPS WHICH RECENTLY ISSUED AN ORDER THAT ALL OPERATIONS CONDUCTED WITHIN THE FIRST CORPS AREA ARE TO BE IMMEDIATELY INVESTIGATED AFTERWARDS TO DETERMINE WHETHER THE PARTICIPANTS ENGAGED IN ILLEGAL ACTS, SUCH AS STEALING. THE NIC IS DIVIDED INTO THE FOLLOWING GROUPS: GROUP ONE - IT IS RESPONSIBLE FOR INTELLIGENCE ON THE PEOPLE'S REVOLUTIONARY ARMY (ERP); GROUP TWO - IT HANDLES INTELLIGENCE ON MONTONEROS; GROUP THREE - THIS GROUP HAS RESPONSIBILITY FOR INTELLIGENCE ON SMALL SUBVERSIVE ORGANIZATIONS, INCLUDING THE PERONIST ARMED FORCES (FAP); GROUP FOUR - THIS GROUP IS RESPONSIBLE FOR INTELLIGENCE ON OTHER SMALL SUBVERSIVE ORGANIZATIONS, INCLUDING PODER OBRERO; GROUP FIVE - IT IS RESPONSIBLE FOR INTELLIGENCE ON THE REVOLUTIONARY COORDINATING JUNTA (JCR). THE CHIEFS OF THE FIVE GROUPS MEET PERIODICALLY TO COORDINATE THEIR ACTIVITIES. ALL OF THE PRESENT NIC PERSONNEL, MOST OF WHOM ARE FROM THE ARMY, ARE ASSIGNED TO THE NIC UNTIL 31 DECEMBER 1977. END SUMMARY.

1. THE MAIN PURPOSE OF THE NATIONAL INTELLIGENCE CENTER (NIC) WITHIN THE GOVERNMENT'S COUNTERSUBVERSIVE CAMPAIGN IS TO DEVELOP AND CONSOLIDATE INFORMATION ON THE VARIOUS LEFTIST TERRORIST GROUPS. THE NIC CARRIES OUT THIS TASK PRIMARILY BY ANALYZING CAPTURED DOCUMENTS AND DATA PROVIDED BY CAPTURED MEMBERS OF SUBVERSIVE GROUPS. THE NIC WORKS IN CONJUNCTION WITH THE INTELLIGENCE UNITS OF THE ARMY, NAVY, AIR FORCE, GENDARMERIE, MARITIME PREFECTURE, FEDERAL POLICE AND BUENOS AIRES PROVINCIAL POLICE, AS WELL AS THE STATE INTELLIGENCE SECRETARIAT (SIDE) AND THE PENITENTIARY INTELLIGENCE SERVICE. THE NIC DOES NOT HAVE COMMAND AUTHORITY OVER THESE VARIOUS INTELLIGENCE UNITS BUT DOES PRESENT REQUESTS WHICH ARE CHANNLED THROUGH REPRESENTATIVES OF THESE UNITS. 2. THE NIC COMES UNDER THE COMMAND OF THE ARMY. ORDERS SENT BY THE ARMY TO THE NIC ARE CHanneled THROUGH THE ARMY G-2 (INTELLIGENCE) OF THE ARMY GENERAL STAFF TO THE ARMY 601ST INTELLIGENCE BATTALION WHICH HAS IMMEDIATE AUTHORITY OVER THE NIC.

3. ON OCCASION NIC MEMBERS MAY PARTICIPATE IN ACTION OPERATIONS, BUT THE OPERATIONS THEMSELVES ARE CONDUCTED BY A UNIT OF ONE OF THE SECURITY SERVICES AND ARE ALWAYS COMMANDED BY AN ARMY OFFICER. ALL OF THE ACTIONS IN WHICH THE NIC PARTICIPATES ARE WITHIN THE JURISDICTION OF THE ARMY FIRST CORPS AND ARE COORDINATED WITH THE FIRST CORPS. ACCORDING TO A RECENT FIRST CORPS ORDER, ANY OPERATION CARRIED OUT WITHIN THE CORPS AREA IS TO BE IMMEDIATELY INVESTIGATED AFTERWARDS TO DETERMINE WHETHER ANY OF THE PARTICIPANTS ENGAGED IN ILLEGAL ACTIVITY, SUCH AS STEALING, DURING THE COURSE OF THE OPERATION.

4. THE NIC IS DIVIDED INTO THE FOLLOWING FIVE GROUPS:

A. GROUP ONE. THIS GROUP IS IN CHARGE OF INTELLIGENCE RELATED TO THE PEOPLE'S REVOLUTIONARY ARMY (ERP). ITS OFFICES ARE WITH THE ARMY 601ST INTELLIGENCE BATTALION AT VIAMONTE AND CALLAO STREETS IN THE FEDERAL CAPITAL. THE CHIEF OF THE GROUP IS A RETIRED MILITARY OFFICER WHO WORKS WITH THE ARMY 601ST INTELLIGENCE BATTALION. HE HAS A DEPUTY PLUS 69 PEOPLE ASSIGNED TO HIM WHO ARE DIVIDED INTO NINE DESKS WITH RESPONSIBILITY AS FOLLOWS: NATIONAL LEADERSHIP OF THE ERP, INTERNATIONAL ASPECTS OF THE ERP, ERP BUENOS AIRES REGIONAL, TUCUMAN REGIONAL, PARANA REGIONAL, CORDOBA REGIONAL, SANTA FE REGIONAL, ROSARIO REGIONAL AND THE "GUEVARIST YOUTH" (ERP YOUTH GROUP).

B. GROUP TWO. THIS GROUP HAS RESPONSIBILITY FOR INTELLIGENCE INVOLVING THE MONTONEROS. ITS OFFICES ARE WITH FEDERAL POLICE INTELLIGENCE ON MORENO STREET IN THE FEDERAL CAPITAL. THE CHIEF IS A FEDERAL POLICE COMMISSIONER, AND THE DEPUTY IS AN ARMY 601ST INTELLIGENCE BATTALION CAPTAIN. THIS GROUP HAS 60 PEOPLE AND IS DIVIDED INTO NINE DESKS WITH RESPONSIBILITIES SIMILAR TO THAT OF GROUP ONE.

C. GROUP THREE. THE GROUP HAS RESPONSIBILITY FOR INTELLIGENCE RELATED TO THE PERONIST ARMED FORCES (FAP), THE COMMUNIST
