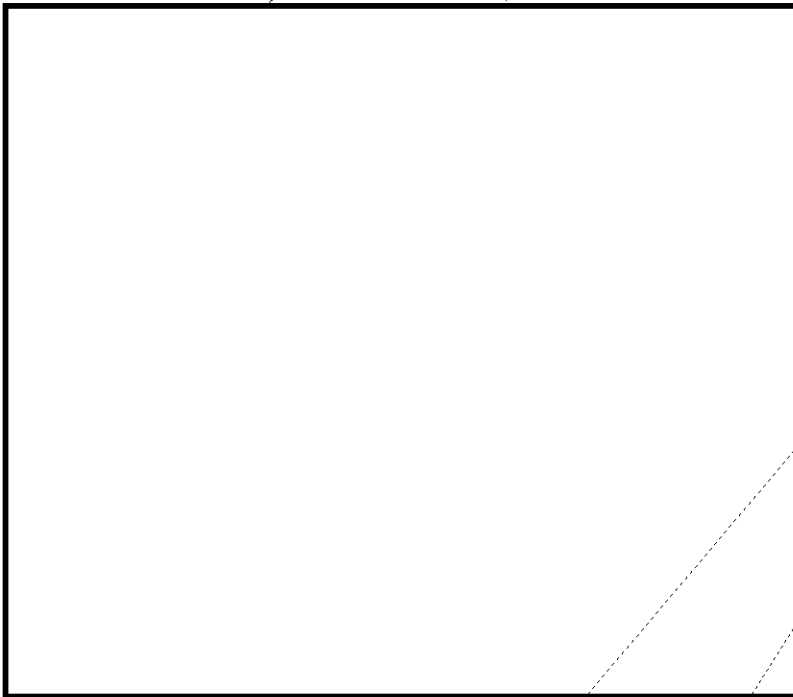

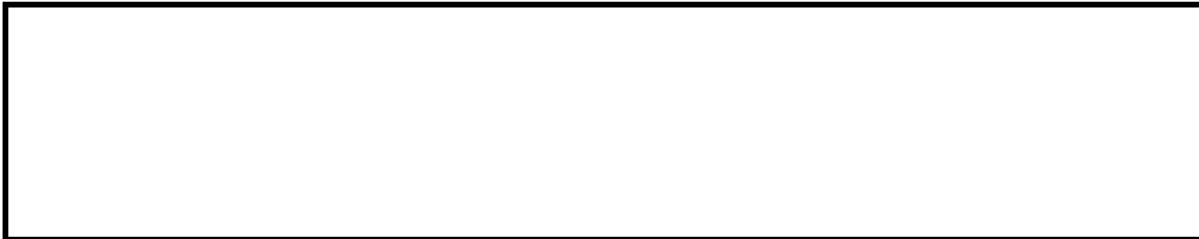

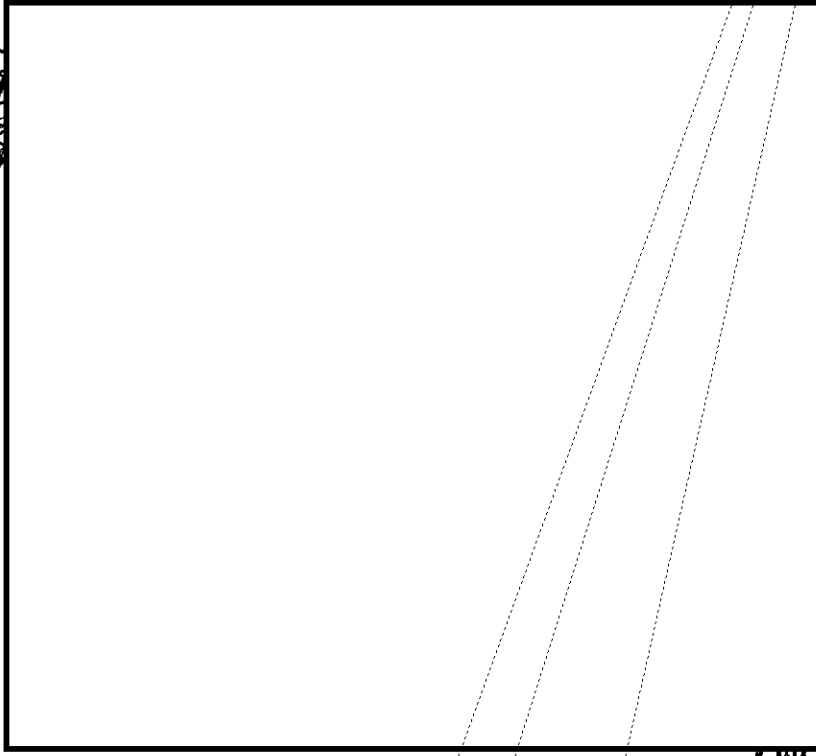

[REDACTED] MONTONERO LEADERS ARE RETURNING TO ARGENTINA TO REVIEW THEIR CONTACTS AND REESTABLISH THE INFRASTRUCTURE OF THE ORGANIZATION. ONE WHO RETURNED RECENTLY WAS RAUL (YAGUER), THE THIRD-RANKING LEADER OF THE ORGANIZATION, WHO WAS KILLED IN CORDOBA ON 30 APRIL. [REDACTED]

[REDACTED] MAR IO (FIRME NICH), SECRETARY GENERAL OF THE MONTONEROS, WAS RECENTLY IN ARGENTINA.

[REDACTED] THE RETURNING MONTONEROS INTEND TO INFILTRATE LABOR AND POLITICAL ORGANIZATIONS, RATHER THAN MAKE PREPARATIONS FOR A RENEWAL OF TERRORISM. HOWEVER, THERE IS ALSO SOME CONCERN THAT THE MONTONEROS MAY TRY TO RETALIATE FOR THE KILLING OF YAGUER. ONE WAY IN WHICH THEY COULD RETALIATE WOULD BE BY THE ASSASSINATION OF A PROMINENT CIVILIAN SUCH AS FORMER MINISTER OF ECONOMY JOSE (MARTINEZ DE HOZ); SUCH AN ASSASSINATION WOULD HAVE THE SECONDARY ADVANTAGE OF BEING VERY POPULAR AMONG THE LARGE NUMBERS OF ARGENTINES WHO BLAME MARTINEZ DE HOZ FOR THE COUNTRY'S ECONOMIC PROBLEMS.

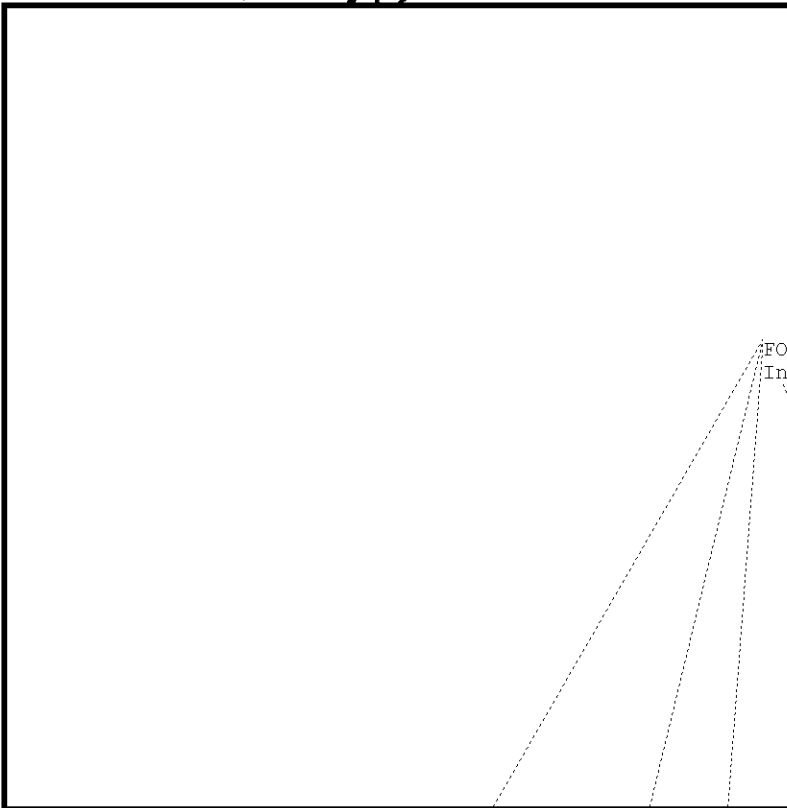

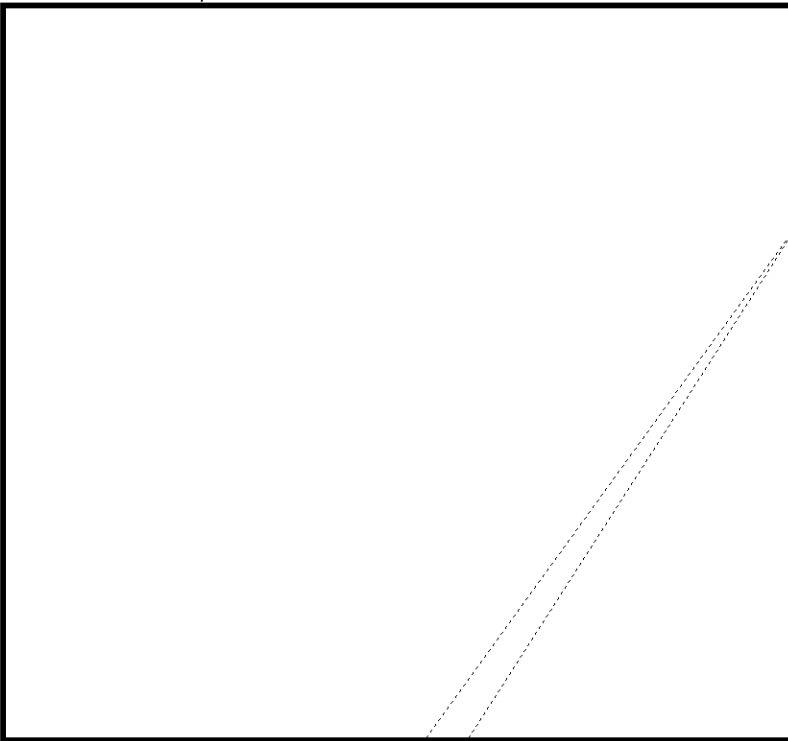
