

[REDACTED] DESCRIBE IN GENERAL TERMS THE PLANS AND ORGANIZATION OF THE TWO RETIRED GENERALS, GIVE THE NAMES OF THE INDIVIDUALS AND ORGANIZATIONS SUPPOSEDLY IN LEAGUE WITH THEM, AND INDICATE SOME OF THE TYPES AND SOURCES OF SUPPORT THAT THEY CLAIM TO HAVE. RETIRED GENERALS CAMPS AND MENENDEZ VERY WELL MAY WANT TO SEE PRESIDENT ALFONSIN REMOVED FROM POWER. THEY ARE PROBABLY QUITE CAPABLE OF TALKING, AND OF DOING SOME PLANNING AND ORGANIZING, ALONG THE LINES DESCRIBED [REDACTED]

THE TWO RETIRED GENERALS AND THEIR ASSOCIATES MAY WELL HAVE THE CAPABILITIES OF USING VIOLENCE AS A TACTIC AND OF ADDING TO DOMESTIC UNEASE. IT IS VERY UNLIKELY THAT THEY HAVE THE CAPABILITY OR THE ORGANIZATION TO DESTABILIZE THE GOVERNMENT OR TO FORCE THE REMOVAL OF THE PRESIDENT, NOR ARE THEY LIKELY TO BE RALLYING POINTS FOR OTHER GROUPS WHO MAY LOOK FOR AN EXTRA-DEMOCRATIC CHANGE OF GOVERNMENT.)

[REDACTED] THE FFAA ARE CAUGHT IN THE MIDDLE OF A STRUGGLE BETWEEN THE ADMINISTRATION AND THE LEFT, WITH THE LEFT WANTING TO CREATE THE IMPRESSION THAT THE NATIONAL REORGANIZATION PROCESS (THE "PROCESO") OF THE ARMED FORCES GOVERNMENT WAS GENOCIDAL.

2. [REDACTED] AT ALL COSTS, THE GOVERNMENT SHOULD NOT LET THE TRIALS OF THE FORMER JUNTA MEMBERS BECOME POLITICAL TRIALS. [REDACTED] THIS WOULD BE A DIFFICULT TASK FOR THE GOVERNMENT BECAUSE OF THE PRESSURE WHICH HUMAN RIGHTS GROUPS ARE EXERTING. ARMED FORCES [REDACTED] DO NOT KNOW WHAT TO EXPECT DURING, OR FROM, THE TRIALS AND, [REDACTED] THE ARMED FORCES AND THE THREE SERVICES, AS INSTITUTIONS, DID NOT SEEM TO HAVE A PLAN FOR COUNTERING THE PUBLICITY WHICH THE TRIALS ARE EXPECTED TO PRODUCE OR FOR DEALING WITH THE RESULTS OF THE TRIALS. 
