The JCR is a planning element, the central element of the strategic plan, and the organizations which participate in the JCR are independent in their respective tactical planning. The JCR's action centers and locations have been selected with great caution, permitting the development of unlimited activities not only because of the legality of its existence in certain countries but because of the facility of contacts on an international scale.

b. Movie Sector: This consists of a team called "Cinema de Base" which produces both short and full-length films in Havana, Cuba, through an agreement with the Cuban-Argentine Cultural Exchange Institute.

c. Documentation Sector: This sector provides logistic support to members of each participating organization in the form of all types of identification papers. The techniques of this sector were developed by the MLN-Tupamaros.

d. Communications Sector: JCR members communicate by means of book codes, generally using books with wide circulation. Messages are sent via regular mail.

e. Team Schools: These are political-military schools, where militant members are prepared for assignments to be carried out later. These schools do not exist in Uruguay at present, but are highly developed in Argentina.

f. Safe-sites Sector [redacted] The Tupamaros are the specialists in this field. They build three types: fixed (in houses), portable, and in vehicles.

4. Characteristics of JCR Action: The JCR is fundamentally a strategic organization, seeking to attain durability, security, development and projection of existing seditious centers, or those in formation in Latin America, with expansionist intentions. In seeking to attain these goals, the JCR focuses on three factors: solidarity, ties among participating organizations, and finances.

a. Solidarity: Primarily assisting persecuted political prisoners or expatriates. Solidarity begins the moment a constituent is detained, through legal support by a select group of lawyers to free the individual, who immediately upon release leaves the country. This accomplished, and depending on the qualifications of the individual, he is given a new position and assignment.

b. Ties among participating organizations [redacted] In this area there is much activity, through contacts of all types, especially with international groups. This offers the possibility of stronger ties, distributing news of the work of seditious organizations internationally, and opportunities to pressure governments.

c. Finances: This area concerns the disbursing of funds obtained from assaults, abductions, and donations. These funds subsidize propaganda campaigns, arms, and logistics, as well as the necessities for clandestine survival.

5. JCR locations: European cities in which qualified Marxist ideologists are located are Paris, Lisbon, Brussels, and Rome. The "chiefs" intend to establish "embassies" in Germany and Holland. [redacted] Comment: [redacted] does not specify whether "Germany" refers to East Germany or West Germany.) Mexico, Cuba and Peru are Latin American countries where there is strong support for the JCR. The National Liberation Army (ELN) in Colombia has initiated contacts with the JCR. Portugal is the headquarters of one of the more important JCR "embassies." The attitude of some Portuguese Army officers toward JCR activities in many cases facilitates the "military training" of JCR members.


