# Argentines/Release

## Jailed American

BUENOS AIRES, March 28—Argentina's new military government last night released and deported the only known U.S. citizen held prisoner here, Olga Talamante, 24, of Gilroy, Calif.

Talamante's case became something of a cause celebre last year when she told visitors to her cell in Azul, 150 miles south of Buenos Aires, that she had been tortured after being arrested in September 1974.

Talamante a Mexican-American, was placed aboard a flight for New York early this morning, U.S. embassy officials here confirmed.

She was arrested and charged with belonging to a clandestine guerrilla organization that had been blamed for a January 1974 attack on the Azul army garrison, a major Argentine military base. She was convicted on the strength of two pistols and guerrilla propaganda found in the slum area apartment from which she and leftist Peronist friends had been working at political organizing in the area. Her attorney argued that the items were planted, but Talamante received a three-year sentence.

At her trial, she told the judge she had been given electric shocks to her teeth, breasts and finger joints and had been threatened with rape. She showed a vis-

that otherwise would have been obtained months ago.

Talamante's deportation is the first such action by the new junta, which overthrew former President Isabel Peron in a coup Wednesday. The Buenos Aires Herald this morning quoted high church sources as saying that Peron, 45, does not want to be exiled to Spain but would prefer to live in retirement in Argentina.

The church sources said

Peron is penniless, despite property holdings of her late husband in Spain. Military sources have indicated that Peron was to be questioned on allegations of corruption and other charges, and her responses made public. Then she was to be flown to exile in Spain. She is now under house arrest at an elegant, castle-like lake district resort called El Tesidor, 800 miles south of Buenos Aires.

She is under tight security, presumably against possible guerrilla attacks that have resumed after a brief pause following the coup. At least 15 persons died in guerrilla battles with police around Argentina yesterday and this morning, 11 of them in volatile Cordoba Province.

Anti-guerrilla action is certain to intensify after Gen. Jorge Rafael Videla, who led the coup, formally assumes the presidency Monday.

His new Cabinet, announced today, will incorporate two civilians as well as two members from each of the three branches of the armed services. The switch to civilian Cabinet ministers

initially was planned to initiate a second stage of slightly relaxed measures, and its beginning so early indicates that the military men in power already feel themselves secure.

The military leaders insisted throughout the coup's planning stages that they were not personally interested in political power. To back that up, the junta announced today that all military personnel in government jobs will receive only their military pay and no additional salary.

They also have bent over backward to avoid seeming vindictive toward Peron or her followers. One newspaper was forced to withdraw a virulently anti-Peronist advertisement.

Instead, they have leaked rather than announced the finding of torture equipment in the Metalworkers Union building when it was taken over the night of the coup. In addition to electric prods, hypodermic needles and prison cells, the soldiers turned up flags of Argentina's various guerrilla groups such as have been found wrapped around bodies in the past. Deaths blamed on those guerrilla groups were often vehemently denied in the leftists' clandestine communiqués. The leader of the metalworkers, Peronist union chief Lorenzo Miguel, vanished the night of the coup.

The location of a number of other major figures also remains a mystery. In the absence of official statements speculation on the number of those arrested ranges from fewer than 1,000 up to 4,500.

In its new manual of guidelines for the local press, the junta tells journalists to "induce the restoration of the values of order, work, dedication, honesty and responsibility in the context of moral Christianity... and avoid the propagation of the opinion of unqualified persons who are without authority to express themselves on matters of public interest."

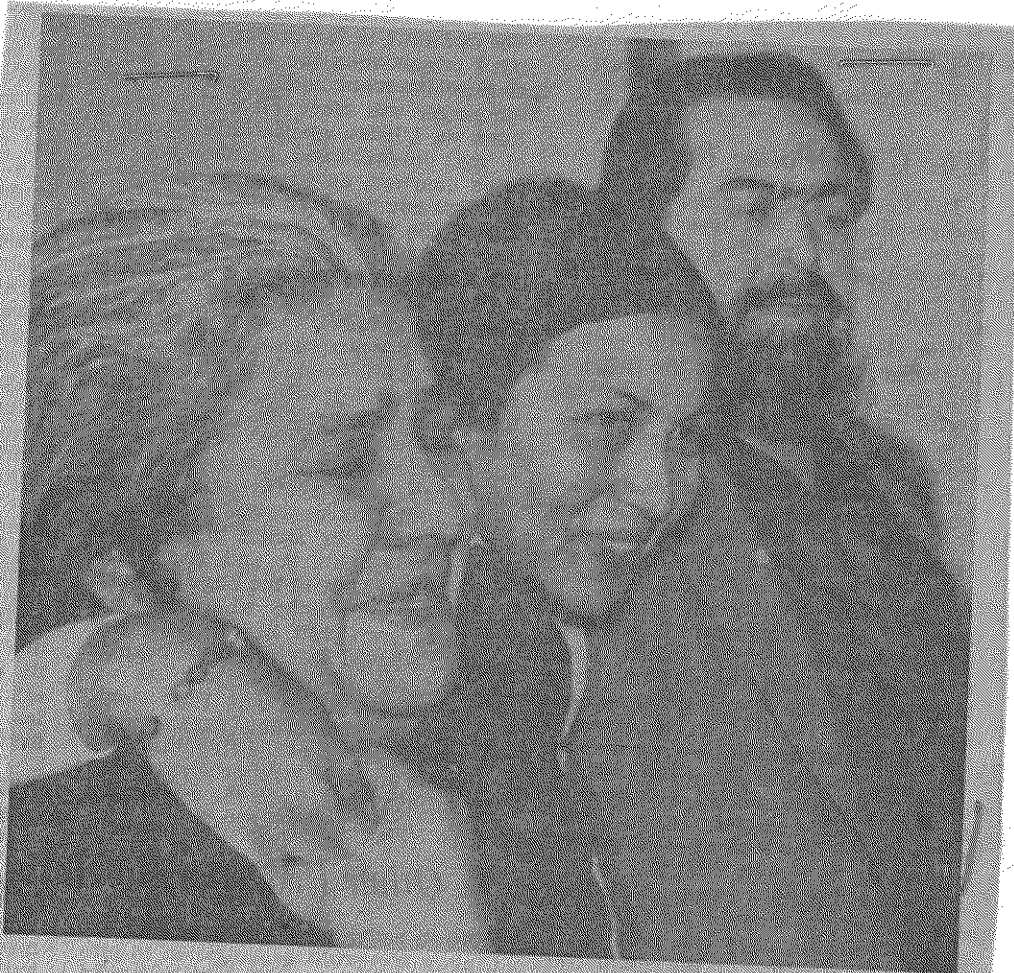

## **Freed American Tells of Torture In Argentine Jail**

A 27-year-old California, flown here yesterday after her release from an Argentine prison, charged that she had been tortured by the Argentine federal police for two days until she falsely confessed to having taken part in subversive acts against the now defunct Peronist Government.

Olga Talamante was arrested Nov. 11, 1974, five days after that Government declared a state of siege. The police, raiding a barbecue in the cattle town of Azul, about 170 miles south of Buenos Aires, also seized a dozen Argentine members of a dissident Peronist youth group and accused them of having two guns and subversive literature.

The Authorities charged at the time that the group was a left-wing terrorist gang responsible for the deaths of a United States consular official and at least 14 Argentines. Miss Talamante, a Mexican-born United States citizen who had stayed in Argentina after a study trip, was convicted of subversive activities and sentenced to three years in prison last September.

Before flying to California yesterday, she said at Kennedy International Airport that the charges were trumped up and that the Azul youth group had run a day-care center and cultural events for local residents. She charged that the guns had been planted by the police.

"I was blindfolded for two days, beaten and given electrical shocks until I signed a confession," she said. Her arrest became known to the United States Embassy in Buenos Aires four weeks later, at which time she reported her treatment.

"We never had any guns; we never had any literature," she said yesterday. "They were planted by the police. The same two guns were used to plant on other persons they wanted to seize."

She said that after the beatings ceased prison conditions were "terrible," with 17 women prisoners sharing a 12-by-15 foot cell.

Miss Talamante, of Gilroy, Calif., was released on orders of the military Government that ousted President Isabel Martinez de Peron last week and deposed as an undesirable alien.

THE LEAFLET DID NOT INDICATE ANY SPONSOR FOR THE DEMONSTRATION.

ON NOVEMBER 7, 1975, ACTING CONSUL NANCLARES WAS ADVISED OF THE ABOVE BY A SPECIAL AGENT OF THE FBI. NANCLARES ADVISED THAT ON NOVEMBER 6, 1975, AN INDIVIDUAL WHO IDENTIFIED HIMSELF AS BOB BARBER, TELEPHONE NO. (465-9544), A FRIEND OF THE TALAMONTE FAMILY, TELEPHONICALLY CONTACTED THE ARGENTINE CONSULATE. BARBER SPOKE WITH NANCLARES AND STATED THAT MRS. TALAMONTE WISHED TO PRESENT A PETITION TO NANCLARES AT 10:30 A.M. JUST BEFORE THE DEMONSTRATION BEGAN. NANCLARES ADVISED BARBER THAT HE WOULD NOT RECEIVE MRS. IN THE DEMONSTRATION: MR. AND MRS. TALAMONTE; ROBERT L. BARBER, 515 28TH AVENUE, OAKLAND, CALIFORNIA, TELEPHONE 465-9444, MEMBER OF THE OLGA TALAMONTE DEFENSE COMMITTEE; BILL BERKOWITZ, MEMBER OF THE OLGA TALAMONTE DEFENSE COMMITTEE; AND MARIA ACOSTA, MEMBER OF SAN FRANCISCO MIME TROUPE.

AT APPROXIMATELY 12 NOON, MR. AND MRS. TALAMONTE AND MARIA ACOSTA, ACTING AS THEIR INTERPRETER AND SPOKESWOMAN, WERE OBSERVED TO ENTER THE FLOOD BUILDING AND GO TO THE ARGENTINE CONSULATE GENERAL, ROOM 408. IN THE HALLWAY IMMEDIATELY OUTSIDE THE CONSULATE, THEY HELD A PRESS CONFERENCE ATTENDED BY A SMALL GROUP OF RADIO AND TELEVISION REPORTERS. ONE TELEVISION REPORTER IDENTIFIED HIMSELF TO THE FLOOD BUILDING MANAGER AS A REPRESENTATIVE OF CHANNEL 8, IN MEXICO CITY.

AT APPROXIMATELY ONE PM THE DEMONSTRATORS BEGAN TO DEPART THE AREA. THE DEMONSTRATORS WERE PEACEFUL AND RELATIVELY ORDERLY AND WERE WELL-CONTROLLED THROUGHOUT THE DEMONSTRATION BY THE SAN FRANCISCO POLICE DEPARTMENT UNIFORMED

OFFICERS AT THE SCENE.

ON NOVEMBER 10, 1975, THE FACTS CONCERNING THE DEMONSTRATION, AS DESCRIBED ABOVE, WERE PRESENTED TO ASSISTANT UNITED STATES ATTORNEY LAURANCE A. CALLAGHAN BY A SPECIAL AGENT OF THE FBI. AUSA CALLAGHAN ADVISED THAT, DESPITE THE FACT THAT THERE WAS A TECHNICAL VIOLATION OF THE PFO STATUTE, IN THAT THE DEMONSTRATORS APPROACHED WITHIN 100 FEET OF A PROTECTED SITE, THAT THE MATTER DID NOT WARRANT FURTHER INVESTIGATION BY THE FBI. IN VIEW OF THE ABOVE, SAN FRANCISCO WILL CONDUCT NO FURTHER INVESTIGATION REGARDING THIS MATTER.

IN FULFILLING THESE OBLIGATIONS, WE FELT WE WERE ACHIEVING TWO OBJECTIVES: A) PROTECTING MISS TALAMANTE'S RIGHTS AND HOPEFULLY SECURING HER FREEDOM AT THE EARLIEST POSSIBLE DATE; AND B) AT THE SAME TIME REMOVING AS EXPEDITIOUSLY AS POSSIBLE AN ISSUE WHICH THREATENED TO DISTURB OUR RELATIONS WITH ARGENTINA.

3. FROM MY LATEST REVIEW OF THE CASE, HOWEVER, I HAVE SOME DOUBT THAT MISS TALAMANTE AND HER MORE ARDENT SUPPORTERS FULLY SHARE OUR CONCERN FOR RAPIDLY ACHIEVING OUR OBJECTIVE OF HER EARLY RELEASE AND DEPARTURE FROM ARGENTINA. IN ATTEMPTING TO SECURE HER RELEASE, WE HAVE REPEATEDLY BROUGHT HER CASE TO THE ATTENTION OF THE HIGHEST LEVEL AUTHORITIES IN THE GOA COMPETENT TO DEAL WITH THE MATTER, E.G., VIGNES, ROCAMORA, ROBLEDO, ETC.

IN WASHINGTON YOU HAVE RAISED THE CASE BOTH WITH AMBASSADOR ORFILA AND AMBASSADOR VAZQUEZ AND MOST RECENTLY WITH THEN FOREIGN MINISTER AND NOW INTERIOR MINISTER ROBLEDO. IN THE LATTER INSTANCE, YOU SECURED HIS PROMISE TO SEEK EARLY RELEASE OF MISS TALAMANTE. ROBLEDO CONFIRMED TO ME UPON HIS RETURN FROM THE U. S. HIS INTENTION TO HONOR THE COMMITMENT. THUS, OVER THE LAST SEVERAL MONTHS WE KEPT THE TALAMANTE CASE CONSTANTLY BEFORE SENIOR OFFICIALS AND WERE FINALLY ABLE TO REACH AN AGREEMENT WITH THEM TO USE THEIR DISCRETIONARY AUTHORITY TO BRING THE MATTER TO A SUCCESSFUL CONCLUSION. HOWEVER, BY A VOLUNTARY ACT ON MISS TALAMANTES PART, I.E., THE DECISION TO APPEAL THE CASE, OUR EFFORTS CAME TO NAUGHT. IN STATE 231451 ROBLEDO WAS REPORTED TO HAVE TOLD YOU HE WOULD TALK TO HER DEFENSE LAWYER RE DROPPING HER APPEAL SO THE EXECUTIVE COULD ACT TO REMOVE HER. WE FIND IT CURIOUS THAT TWO DAYS AFTER WE RECEIVED THE TELEGRAM AND BEFORE ROBLEDO RETURNED TO BUENOS AIRES THE DEFENSE ATTORNEY PHONED US AND SAID HE HAD BEEN FIRED BY TALAMANTE AND HER CODEFEDENTANTS, THUS REMOVING ROBLEDO'S LEVERAGE.

4. WE MUST, OF COURSE, CONTINUE TO SEEK MISS TALAMANTE'S RELEASE OR AT LEAST TO MAKE CERTAIN SHE CONTINUES TO RECEIVE FAIR TREATMENT. I WISH, HOWEVER, TO BRING TO YOUR PERSONAL ATTENTION SEVERAL DISTURBING ASPECTS OF THE CASE WHICH CAST DOUBT ON MISS TALAMANTE'S OWN COMMITMENT TO GAINING HER FREEDOM AT THE EARLIEST MOMENT. HER SUPPORTERS, BOTH HERE AND IN THE U. S., MAY HAVE OBJECTIVES WHICH GO BEYOND SECURING HER RELEASE FROM JAIL. WHY, FOR EXAMPLE, DID SHE THWART EFFORTS TO SECURE HER REMOVAL FROM THE COUNTRY? 6. IN APPLYING FOR HER PASSPORT EXTENSION MISS TALAMANTE ROUTINELY COMPLETED AN EMBASSY REGISTRATION FORM GIVING HER ADDRESS AS RECONQUISTA 865, BUENOS AIRES. THIS ADDRESS PROVED TO BE A FALSE ONE. ON INVESTIGATION WE DETERMINED THAT THERE IS NO SUCH ADDRESS ON RECONQUISTA STREET. THE 800 BLOCK OF RECONQUISTA STREET IS A SLUM AREA CONSISTING OF SHABBY TENEMENT-TYPE ROOMS AND B-GIRL NIGHT CLUBS CATERING TO SEAMEN AND DRIFTERS.

7. WE HAVE NO ADEQUATE EXPLANATION WHY MISS TALAMANTE CHOSE TO GIVE A FALSE ADDRESS TO THE EMBASSY. HOWEVER, THE GIVING OF A FALSE ADDRESS WOULD APPEAR TO SUGGEST THAT MISS TALAMANTE FELT SHE HAD SOME GOOD REASONS OF HER OWN TO MISLEAD THE EMBASSY ABOUT HER TRUE WHEREABOUTS IN ARGENTINA.

8. TO IMPUTE TOO MUCH TO THE FACT THAT MISS TALAMANTE GAVE A FALSE ADDRESS ON HER REGISTRATION FORM WOULD NOT BE FAIR TO HER AND IF IT HAD BEEN AN ISOLATED INCIDENT WE MIGHT WRITE IT OFF AS A SIMPLE ERROR. LIKEWISE, THE LOSS OF TWO PASSPORTS IN 1972 COULD, IF SEEN AS ISOLATED INCIDENTS, BE ATTRIBUTABLE TO BAD LUCK. HOWEVER, ACCORDING TO A REPORT IN OUR FILES, SHE WAS ARRESTED ON FEBRUARY 14, 1972 ON THE COSTA RICA-NICARAGUAN BORDER AND CHARGED WITH POSSESSION OF COMMUNIST LITERATURE. REPORTEDLY, HER LUGGAGE CONTAINED NUMEROUS PAMPHLETS, BOOKLETS, ETC., OF LITERATURE OF THE COMMUNIST PARTY OF NICARAGUA, LITERATURE SUPPORTING ANGELA DAVIS, AND LITERATURE OF A CUBAN-ORIENTED TERRORIST GROUP--THE (FSLN). THE POSSESSION OF PRO-CUBAN LITERATURE AND THE FACT THAT MISS TALAMANTE LOST TWO PASSPORTS MAY BE UNRELATED. BUT IT DOES GIVE GROUNDS TO SPECULATE, AS THE FBI REPORT DID, THAT HER LOST PASSPORTS MAY HAVE ENABLED HER TO CONCEAL TRAVEL TO CUBA. HER ACTIVITIES WHILE IN CENTRAL AMERICA, MOREOVER, MAKE IT CLEAR SHE DID NOT CHOOSE HER ASSOCIATES IN ARGENTINA ON A RANDOM BASIS. AT LEAST TWO OF THE PERSONS WITH HER IN COSTA RICA/NICARAGUA WERE ARRESTED WITH HER IN AZUL.

9. OUR FILES ALSO CONTAIN A PRESS ACCOUNT STATING THAT MISS TALAMANTE WAS ARRESTED IN CHIAPAS, MEXICO, IN 1972 AND DETAINED FOR ONE WEEK. WE HAVE NO INFORMATION AS TO THE NATURE OF ANY CHARGES AGAINST HER. IT IS SUGGESTED THAT THE DEPARTMENT MAY WISH TO INQUIRE OF EMBASSIES IN MEXICO, MANAGUA AND SAN JOSE CONCERNING ANY RECORDS THEY MAY HAVE IN THIS REGARD.

10. TO CONTINUE WITH MISS TALAMANTE'S CASE IN ARGENTINA, WE DID NOT HEAR OF HER AGAIN UNTIL SHE WAS ARRESTED IN AZUL ON NOVEMBER 10, 1974, ALONG WITH ABOUT A DOZEN ARGENTINE NATIONALS.

11. ALMOST IMMEDIATELY AFTER HER ARREST, A MASSIVE LETTER-WRITING CAMPAIGN WAS MOUNTED ON HER BEHALF BY THE "OLGA TALAMANTE DEFENSE COMMITTEE." IN ADDITION TO HUNDREDS OF LETTERS FROM THE U. S. ON HER BEHALF, WE RECEIVED A PETITION FROM SWEDEN AND CORRESPONDENCE FROM AS FAR AWAY AS TANANARIVE AND TASMANIA. THE LETTERS AND TELEGRAMS DIFFERED FROM THE MAIL USUALLY RECEIVED URGING HUMANITARIAN SUPPORT FOR JAILED U. S. CITIZENS. IN OLGA'S CASE, FROM THE OUTSET HER SUPPORTERS SEEMED LESS CONCERNED WITH HER GUILT OR INNOCENCE THAN IN CASTIGATING THE "FASCIST" GOA FOR HAVING ARRESTED HER AND THE "IMPERIALIST" U. S. FOR AIDING AND ABETTING THIS ACTION. MUCH OF THE MAIL WAS ABUSIVE IN TONE AND ONE LETTER FROM BERKELEY WAS THREATENING TO ME PERSONALLY AND HAS BEEN TURNED OVER TO THE FBI.

12. CURIOUSLY, THOUGH AWARE OF THE CASE, THE LOCAL OPPOSITION PRESS (WHICH HAS OFTEN TAKEN UP THE CUDGELS FOR MANY PERSONS BELIEVED VICTIMS OF GOA OPPRESSION) HAS REFRAINED FROM RAISING ANY BANNERS FOR OLGA AND HER CODEFENDANTS.

13. THROUGHOUT THIS CASE, THE GOA FROM ALL EVIDENCE AVAILABLE TO US HAS IN NO WAY DISCRIMINATED AGAINST MISS TALAMANTE IN THE PROSECUTION OF HER CASE. NOR, ACCORDING TO MISS TALAMANTE HER-

SELF, HAS SHE, WITH THE EXCEPTION OF THE TIME IMMEDIATELY FOLLOWING HER ARREST, BEEN MISTREATED DURING HER INCARCERATION. THOUGH LOCAL PRACTICES DIFFER FROM U. S. LEGAL NORMS, WE HAVE EVERY REASON TO BE SATISFIED THAT MISS TALAMANTE RECEIVED DUE PROCESS UNDER ARGENTINE LAW. THIS, DESPITE THE FACT THAT THE GOA WAS HEAVILY ENGAGED IN COMBATING A SERIOUS TERRORIST PROBLEM. NOT ONLY IN APPLICATION OF ARGENTINE POLITICAL NORMS BUT IN PERSONAL CONTACTS WITH SENIOR GOA OFFICIALS, I HAVE FOUND THEM IN EVERY CASE TO BE HEOPFUL WITHIN THEIR RESPECTIVE COMPETENCES IN DEALING WITH THIS MATTER.

14. NOR CAN IT BE OVERLOOKED THAT THE GROUP IN AZUL WERE "MONTONEROS" AND THAT THE MONTONEROS ALONG WITH THE ERP ARE OUTLAWED TERRORIST GROUPS DEDICATED TO DESTROYING THE PRESENT ARGENTINE GOVERNMENT. IT WAS A GROUP WITHIN THE MONTONERO ORGANIZATION WHICH KIDNAPPED AND MURDERED OUR CONSULAR AGENT IN CORDOBA, JOHN EGAN, A FRIEND AND FORMER CONSTITUENT OF SENATOR MANSFIELD.



15. CONCLUSION: I AM NEITHER MISS TALAMANTE'S JUDGE NOR HER JURY. SHE WAS GIVEN A FAIR TRIAL AND WAS CONVICTED. WE WILL, OF COURSE, CONTINUE TO PROVIDE HER WITH ALL APPROPRIATE PROTECTIVE SERVICES AND INSURE THAT SHE CONTINUES TO HAVE FAIR TREATMENT FROM THE ARGENTINE COURTS AND PENAL AUTHORITIES. WE WILL ALSO CONTINUE TO SEEK HER REMOVAL FROM THE COUNTRY SO AS TO MINIMIZE IRRITATION TO OUR BILATERAL RELATIONS WITH ARGENTINA. THE LONGER SHE IS HERE, THE MORE THE CASE BECOMES A CAUSE CELEBRE WITH CERTAIN ELEMENTS OF THE U. S. PRESS, AND, THUS, THE GREATER THE LIKELIHOOD OF AN ARGENTINE REACTION. HENCE, IT IS IN OUR INTERESTS TO GET HER OUT OF HERE AS EARLY AS POSSIBLE. NOTHING WOULD PLEASE ME MORE THAN TO SEE HER DEPORTED TOMORROW. MEANWHILE, HOWEVER, I SEE NO NEED FOR US TO BE APOLOGETIC ABOUT THE PROTECTION SHE HAS BEEN AFFORDED BY THE USG THUS FAR (A CONCLUSION FULLY SUPPORTED BY THE RECENT INSPECTORS' REPORT). ON THE CONTRARY, WE HAVE GIVEN MORE TIME AND EFFORT TO HER CASE THAN TO ANY PROTECTION CASE IN THE RECENT HISTORY OF THIS POST--EFFORT WHICH HAS INCLUDED OVER FIFTEEN VISITS BY EMBOFFS TO AZUL. FURTHER, I SUGGEST THAT IF CRITICISM PERSISTS IN CONGRESSIONAL AND PRESS CIRCLES, WE MAKE AVAILABLE TO THEM INFORMATION REGARDING MISS TALAMANTE'S BACKGROUND. THIS IS NOT A POOR LITTLE GIRL WITH SAD EYES WHO INNOCENTLY MADE A WRONG TURN ONTO A ONE-WAY STREET.

# U.S. Citizen Tortured in Argentina

We have seen enough of the seamy side of life to harden us to shock. But the letters that are smuggled to us from torture victims always leaves us shaken.

Priests who have been permitted inside the prisons of Brazil have brought us, at great personal risk, evidence of the inhumanity of the Brazilian military regime.

Friends and relatives have smuggled out letters from Cuban political prisoners, describing the horrors of Fidel Castro's concentration camps. We have spoken to an American girl, a gentle art teacher, who had been tortured by the Chilean military junta.

The latest letters have been delivered to us by friends of Olga Talamante, a 25-year-old U.S. citizen who has been beaten and tortured with electric shock at a federal police station in the provincial town of Azul, Argentina. Her letters to her farm worker parents and former school friends in California are graphic.

"We spent four days and four nights which were pure hell," she related. "They beat the hell out of us. . . There was no difference between day and night, as our heads were covered with coarse cloth bags, and we weren't allowed to sleep.

"We were constantly interrogated and, of course, 'persuaded' with a special electric gadget to talk. The combination of physical punishment and psychological stress is something they've practiced for a long time, because they are really good at it.

"But not good enough!" she wrote in an aside from her cell.

"It's impossible to describe everything we went through, but it is very real. To think," she wrote, "that many other people have gone through it and have even died of it gives one a different dimension on one's own situation."

Talamante, who is in a cell with five women, indicated they are now being treated well and "have everything we need except dear freedom."

In the writing style of Anne Frank, whose family hid out from the Germans in Amsterdam during World War II, Talamante observed: "Ironically enough, there is a bird's nest on the jail's roof. I asked myself why that free dove chose a jail's roof to build its home. It's as if it wants to remind us that freedom still exists."

The American girl was arrested with a dozen Argentines just a few days after a state of siege was declared in Argentina. Police reports charge that the arrest site contained arms and subversive materials, which

could bring a minimum three-year prison sentence under the sweeping new laws.

A former honor student at the University of California in Santa Cruz, Talamante journeyed to Argentina in August, 1973, with money earned picking garlic. She taught English in Azul and planned to return to the United States on Nov. 24 for Thanksgiving.

A friend, Rebecca Estrada, recalls that Talamante was particularly interested in political corruption in CIA-supported military regimes even though "she realized she was getting into heavy stuff."

An Argentine embassy spokesman told our reporter, Rozanne Weissman, that "This case cannot be compared to those in Chile because we don't torture people in Argentina" and "we still have our legal procedures in force even during our state of siege."

Even more depressing are letters from Antonio Cuesta Valle, blind and maimed, who, nevertheless, is held by Fidel Castro in a brutal Cuban prison. Cuesta asked his friends to bring his story to us, although he expects retaliation, when it is printed.

He led a commando raid on Cuba in 1966. His small boat was intercepted by patrol boats, and four of his associates were killed in an exchange of gunfire. Cuesta urged the only other survivor, Eugenio Zaldivar, that

they cheat the firing squad and commit suicide.

They exploded a hand grenade which blew off one of Cuesta's arms, destroyed his eyesight and riddled his body with shrapnel. Yet he survived. His companion lost the use of one leg.

In the hospital, they received minimum medical care and scarcely enough food to stay alive. The hospital was infested with rats, bedbugs and cockroaches.

Now in a special gallery for political prisoners, Cuesta writes of beatings and brutality by the guards, and of the constant "requisas" or searches. The prisoners are stripped naked and chased into the patio by guards who strike them with clubs.

Cuesta also must recruit a fellow prisoner to dress and shave him. As quickly as he becomes dependent upon someone, the guards sadistically move the prisoner and leave Cuesta on his own again.

Yet this blind man with one arm is able to write Spanish poetry and conduct clandestine church-services in the prison. He knows the guards will punish him when the news of this is published. But he wants the world to know.

"I am sure that I will never leave this prison alive," he writes, "and there is nothing anyone can do about it."

The name LAGLAS appeared among the names of a number of co-sponsors on a leaflet circulated in March 1974 urging attendance at a meeting scheduled in Los Angeles April 10, 1974. It was to feature Harald Edelstam, Sweden's Ambassador to Chile, when the military coup occurred.

On September 23, 1974, the second source furnished the following information:

LAGLAS was co-sponsor of a picket line demonstration and rally on September 11, 1974, in front of the Chilean Consulate in Los Angeles. About 50 persons attended and the head speakers alleged the United States Central Intelligence Agency had been involved in the military coup in Chile.

The "UCLA Daily Bruin" November 12, 1974, on Page 1 carried an article regarding the University of California (UC) involvement with the University of Chile. UC recently decided to continue a project in Chile despite heavy criticism of the military junta in Chile and claims the "Convenio" project supported the junta. "Many faculty and staff, including specialist on Latin American studies, disagree. Through groups such as LAGLAS, they are pressing their belief that the University position is a deception based on intentional denial of the facts involved and disregard of the opinion of the university community".

**American Woman  
Held in Argentina  
Charges Torture**

BUENOS AIRES, Dec. 9—An American woman who has been under police detention for four weeks, has charged that she was subjected to electric shocks and beatings, the United States Embassy here reported today. The woman, Olga Talamante, 25 years old, was arrested by the Argentine police on Nov. 11 with 12 Argentines in the city of Azul, about 170 miles south of the capital.

According to the police, the group was detained in a house that contained firearms and other subversive material.

Miss Talamante, a naturalized American citizen born in Mexicali, Mexico, has no official charges against her. She was arrested under the provisions of the state of siege in effect in the country since Nov. 6, which permit the authorities to detain people without charges.

**Visited by Official**

According to the United States Ambassador, Robert C. Hill, Miss Talamante did not seek to inform the embassy of her arrest nor did she request aid from United States officials here.

On Nov. 25 State Department officials in Washington informed the embassy of her arrest, and a United States consular official visited her on last Wednesday. Embassy officials said they maintained contact with Miss Talamante and the judge handling her case both before and after visiting her.

According to embassy spokesmen, the judge said he would investigate Miss Talamante's charges of mistreatment.

Miss Talamante arrived in Argentina in August, 1973, and registered with the United States Embassy as a student. According to local newspaper accounts of her arrest, she also taught English here.

The lawyer who initially represented her has dropped the case, and the court is supposed to select another lawyer to defend her and her companions. There is no indication when charges will be brought against her or when her case will be brought into court, according to the United States Embassy.
