

OUR REPRESENTATIVE IN BUENOS AIRES REPORTED THAT DURING THE AFTERNOON OF FEBRUARY 27, 1975, A COMMUNIQUE WAS RECEIVED FROM THE MONTONERO GUERRILLA ORGANIZATION IN CORDOBA, ARGENTINA, INDICATING THAT U.S. CONSULAR AGENT JOHN PATRICK EGAN WOULD BE EXECUTED AT SEVEN P.M., FEBRUARY 28, 1975, UNLESS FOUR TERRORISTS ALLEGEDLY TAKEN PRISONER BY THE GOVERNMENT ARE PRODUCED. (u)

A CONFIDENTIAL SOURCE WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST ADVISED THAT AT LEAST TWO OF THE TERRORISTS WERE SUMMARILY EXECUTED BY FEDERAL POLICE OF ARGENTINA OFFICERS IN CONNECTION WITH THE "NO HOLDS BARRED" CAMPAIGN AGAINST TERRORISM IN ARGENTINA. (u)
