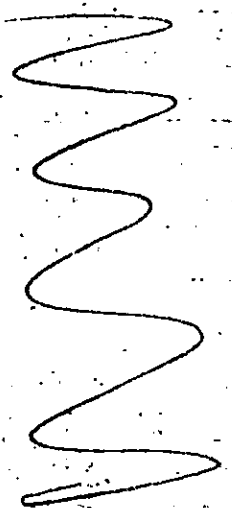

ON MARCH 4, 1975, COMISARIO GENERAL LUIS MARGARIDE, CHIEF OF THE FEDERAL POLICE OF ARGENTINA (FPA), NOTED THAT THE MONTONERO GUERRILLA ORGANIZATION HAD KIDNAPPED ON SEPTEMBER 19, 1974, JORGE BORN, JR. AND JUAN C. BORN, BROTHERS WHO ARE CONNECTED WITH ONE OF ARGENTINA'S MOST IMPORTANT PRIVATE BUSINESS COMPANIES, THE BUNGE & BORN COMPANY.
