FOREIGN POLITICAL MATTERS-ARGENTINA; IS-ARGENTINA; ARGENTINE TERRORIST ACTIVITIES; FPM-ARGENTINA.

ON JANUARY 29, 1976, A CONFIDENTIAL SOURCE ABROAD WHO IS AN OFFICER OF THE BUENOS AIRES PROVINCIAL POLICE (BAPP) INTELLIGENCE SERVICE, PROVIDED THE FOLLOWING INFORMATION:

ON JANUARY 29, 1976 AT APPROXIMATELY 9:45 AM, FIFTEEN ARMED INDIVIDUALS, INCLUDING TWO WOMEN, FORCIBLY TOOK OVER THE BENDIX PRODUCTS CORPORATION PLANT IN MUNRO, BUENOS AIRES ARGENTINA

THE INDIVIDUALS ENTERED THE BENDIX CORPORATION LOCATION IN A PICKUP TRUCK AND FOUR AUTOMOBILES. THE INDIVIDUALS WERE ARMED WITH AUTOMATIC WEAPONS. THE INTRUDERS DEMANDED THAT THE

PRESIDENT AND GENERAL MANAGER OF THE BENDIX CORPORATION BE PRODUCED BUT WERE INFORMED THAT THE FORMER WAS IN EUROPE AND

THAT THE LATTER HAD NOT YET ARRIVED AT THE COMPANY INSTALLATION. AT APPROXIMATELY THE SAME TIME THAT THE TERRORISTS WERE DEMANDING

TO SEE THE BENDIX CORPORATION PRESIDENT AND GENERAL MANAGER, THE CHIEF OF PERSONNEL AND THE CHIEF OF INDUSTRIAL RELATIONS OF THE BENDIX CORPORATION, BOTH ARGENTINE CITIZENS, ARRIVED AT WORK. THE TERRORISTS UNCEREMONIOUSLY GUNNED THEM DOWN AND ALSO KILLED A BAPP CORPORAL WHO ATTEMPTED TO COME TO THE EXECUTIVES' DEFENSE. ~~(S)~~

THE BENDIX CORPORATION HAS BEEN HAVING RECENT LABOR PROBLEMS AND IT IS BELIEVED THAT ~~THE MONTONERO GUERRILLA ORGANIZATION~~ WAS RESPONSIBLE FOR THE ABOVE-DESCRIBED ATTACK, ALTHOUGH AS OF 11:30 AM, JANUARY 29, 1976, THE CUSTOMARY COMMUNIQUE FROM THE ORGANIZATION RESPONSIBLE FOR THE ASSASSINATIONS HAD NOT YET BEEN RECEIVED BY THE BUENOS AIRES NEWS MEDIA.
