THE FOLLOWING RECEIVED FROM BUREAU LEGAL ATTACHE, BUENOS AIRES.

ON FEBRUARY 18, 1976, AN UNIDENTIFIED MALE, SPANISH-
SPEAKING INDIVIDUAL, CALLED THE PAN AMERICAN WORLD AIRWAYS
(PAWA), RESERVATIONS DEPARTMENT, IN BUENOS AIRES, ARGENTINA.
THE CALLER STATED THAT THE LIFE OF HAL WILLIAMS, PAWA MANAGING
DIRECTOR FOR ARGENTINA, CHILE AND URUGUAY, WAS IN DANGER AND
THAT WILLIAMS WOULD BE EXECUTED. THE CALLER INDICATED HE WAS A
MEMBER OF THE MONTONERO GUERRILLA ORGANIZATION ALA 22 (WING 22).

THE FOREGOING INFORMATION WAS REPORTED TO THE FEDERAL POLICE
OF ARGENTINA DURING THE AFTERNOON OF FEBRUARY 18, 1976. [A

RALPH NEGRI, ARGENTINE DELEGATE, PAWA, BUENOS AIRES, ADVISED THAT PAWA IS IN THE MIDST OF NEGOTIATIONS OF WAGE INCREASES FOR EMPLOYEES AND THAT THERE IS A POSSIBILITY THAT THE ABOVE DESCRIBED THREAT AGAINST THE LIFE OF WILLIAMS MAY BE RELATED TO WAGE NEGOTIATIONS CURRENTLY BEING CONDUCTED BY PAWA.
