OUR REPRESENTATIVE IN BUENOS AIRES HAS ADVISED AS FOLLOWS:

ON MARCH 26, 1976, A CONFIDENTIAL SOURCE ABROAD WHO IS

A RANKING OFFICIAL OF THE ARGENTINE ARMY INTELLIGENCE SERVICE (AAIS), PROVIDED THE FOLLOWING INFORMATION: (S)

INTELLIGENCE RECENTLY ACQUIRED BY THE AAIS ESTABLISHED

THAT MARIO ROBERTO SANTIUCHO, THE LEADER OF THE ARGENTINE GUERRILLA ORGANIZATION, THE PEOPLE'S REVOLUTIONARY ARMY

(ERP), RECENTLY FORWARDED A MESSAGE TO CUBAN PREMIER FIDEL CASTRO REQUESTING THAT 2,500 CUBAN TROOPS BE SENT TO ARGENTINA

TO ASSIST THE ERP IN CARRYING OUT GUERRILLA ACTIVITIES THAT WOULD EVENTUALLY LEAD TO THE DOWNFALL OF THE ARGENTINE GOVERNMENT.

SANTIUCHO'S REQUEST WAS DENIED BY FIDEL CASTRO. THIS INTELLIGENCE

HAS CLEARLY DEMONSTRATED THE SIGNIFICANCE OF RECENT CUBAN

INTERVENTION IN ANGOLA TO MEMBERS OF THE ARGENTINE ARMED
