1. WE WELCOME PROSPECT OF YOUR VISIT AND ARE CONFIDENT THAT GOA WILL ALSO.

2. SCHEDULE:

THOUGH WE ORIGNIALLY THOUGHT TOP GOA OFFICIALS WOULD BE AVAILABLE, VENEZUELAN AMBASSADOR TO ARGENTINA ANNOUNCED LAST EVENING THAT PRESIDENT VIDELA ACCOMPANIED BY FONMIN GUZZETTI WILL MAKE A FOUR-DAY STATE VISIT TO VENEZUELA BEGINNING MAY 11. DESPITE ABSENCE OF THESE OFFICIALS, WE STILL BELIEVE YOUR VISIT COULD BE AN EXTREMELY CONSTRUCTIVE FACTOR IN OUR BILATERAL RELATIONS. AMB HILL WILL HAVE DEPARTED MAY 10, AND WHILE HE WOULD LIKE TO BE PRESENT FOR YOUR VISIT, IT WOULD BE MOST DIFFICULT TO EXTEND BECAUSE OF COMMITMENTS ALREADY MADE.

ON YOUR TIME BY GOA OFFICIALS BEYOND THAT SKETCHED IN THE PROPOSED
AGENDA ABOVE; THE DIFFICULTIES IN GETTING AND MIXING A REPRESENTA-
TIVE SAMPLE AT ONE GATHERING; THE FACT THAT AMPLE CONTACT WITH
THESE GROUPS WAS ACHIEVED DURING THE PREVIOUS BRAY AND DERIAN
VISITS.
