SUBJ: MEETING BETWEEN ASSTANT SECRETARY TODMAN AND
PRESIDENT VIDELA OF ARGENTINA

1. WITH THE SPECIAL ASSISTANCE OF THE VENEZUELAN GOVT,
ARRANGEMENTS WERE MADE FOR A 25-MINUTE MEETING BETWEEN
ASSISTANT SECRETARY TODMAN AND PRESIDENT VIDELA. THE
MEETING OCCURRED ON MAY 11 BETWEEN THE PRESIDENT'S
ARRIVAL AT THE AIRPORT AND THE TRADITIONAL WREATH-LAYING
CEREMONY AT BOLIVAR'S TOMB.

2. VIDELA BEGAN BY SAYING THAT HE HAD BEEN CONCERNED TO
LEARN THAT I WOULD BE IN BA AT A TIME WHEN HE WOULD
BE ABSENT, THE FOREIGN MINISTER HOSPITALIZED FOLLOWING
THE BRUTAL ATTACK AND OTHER LEADING FIGURES OF
THE GOVT PRESENT IN VENEZUELA. THIS MEANT
THAT HIS GOVT WOULD NOT HAVE BEEN ABLE TO GIVE
ME THE KIND OF RECEPTION AND ATTENTION THEY WOULD
HAVE LIKED. HE WAS THEREFORE VERY RELIEVED AND
PLEASED THAT IT WAS POSSIBLE FOR THIS MEETING TO
TAKE PLACE.

3. VIDELA SAID THAT HE BELIEVED IN THE VALUE OF PERSONAL
CONTACT FOR THE BUILDING OF UNDERSTANDING AND THAT WAS
WHAT ARGENTINA WAS SEEKING. THEY WERE COMMITTED TO THE
DIGNITY OF THE INDIVIDUAL AND THE PROMOTION OF HUMAN
RIGHTS. THEY WERE TROUBLED THEREFORE TO FIND THEMSELVES
IN THIS SITUATION IN WHICH THE WELL-BEING OF THE COUNTRY
WAS BEING ATTACKED BY TERRORISTS AND GUERRILLAS. HE
DID NOT CALL IT A WAR BECAUSE HE DID NOT WISH TO DIGNIFY
THE ENEMIES OF THE COUNTRY WITH THE CONDITION OF
BELLIGERENCY BUT, IN FACT, IT WAS A WAR SITUATION THAT
THEY WERE FACING. THE COUNTRY WAS GOING THROUGH THREE
CRISES AT THE SAME TIME-- THE POLITICAL CRISIS WITH
THE POLITICAL SYSTEM IN DISARRAY AND THE COUNTRY ABOUT
TO DISINTEGRATE, THE ECONOMIC CRISIS AND NOW THE ATTACKS
OF VIOLENCE. THE OPPONENTS OF THE REGIME WERE ATTACKING
ON ALL FRONTS INCLUDING THE PSYCHOLOGICAL. PART OF THE
REASON FOR THE ATTACK ON THE FOREIGN MINISTER WAS TO
ABORT THE PRESENT VISIT TO VENEZUELA. IT WAS THEIR
INTENTION TO USE THIS AS FURTHER JUSTIFICATION OF FEAR ON
THE PART OF THE GOVT AND ITS INABILITY TO FUNCTION.
IT WAS TO DENY THEM THIS POSSIBILITY THAT HE HAD
DECIDED TO CONTINUE WITH THE VISIT.

TIME TO RECEIVE ME. I SAID THAT I SHARED HIS BELIEF IN THE IMPORTANCE OF PERSONAL CONTACT AND WELCOMED THE OPPORTUNITY TO EXPLAIN TO HIM OUR VIEWS ON THE GENERAL PROBLEM OF HUMAN RIGHTS TO WHICH HE HAD REFERRED. FIRST I WISHED TO EXPRESS MY REGRET FOR THE BRUTAL ATTACK ON THE FOREIGN MINISTER AND MY HOPE FOR HIS COMPLETE AND SPEEDY RECOVERY. I WAS HAPPY HOWEVER THAT HE HAD DECIDED TO MAKE THE TRIP IN ANY EVENT, SINCE THE MORE THE GOVT COULD SHOW THAT IT WAS IN CONTROL OF THE SITUATION BY CARRYING OUT ITS NORMAL FUNCTIONS AND BY APPLYING THE LAW THE LESS WOULD BE THE VICTORY OF THE

TERRORISTS IN THIS REGARD. I SAID THAT WE UNDERSTOOD THE NEED FOR THEM TO TAKE FIRM ACTION BUT THAT THE MORE RESTRAINT DEMONSTRATED BY THE GOVT IN TERMS OF THE MEASURES USED AND THE AVOIDANCE OF RETALIATION IN KIND THE GREATER WOULD BE THE PROSPECTS FOR UNDERSTANDING OF WHAT THE GOVT WAS TRYING TO DO. THE MORE FOREIGNERS OR OUTSIDERS THAT COULD VISIT AROENTINA TO OBTAIN A TRUE PICTURE OF THE SITUATION THE BETTER WOULD BE THE OPPORTUNITY FOR GAINING UNDERSTANDING.

5. I ADDED THAT I WAS SORRY THE SCHEDULING PROBLEMS WOULD NOT PERMIT ME TO VISIT BA ON THIS TRIP BUT THAT I WOULD TRY TO INCLUDE IT ON THE VERY NEXT TRIP I TOOK TO THE AREA. PRESIDENT VIDELA SAID THAT HE WOULD LOOK FORWARD TO RECEIVING ME THERE. HE UNDERSTOOD OUR POSITION IN DEFENSE OF HUMAN RIGHTS AND HOPED WE WOULD UNDERSTAND THE PROBLEMS HE FACED IN APPLYING IT IN THE SAME WAY, GIVEN THE SITUATION HE FACES.
