3. EMBASSY IS IN BEST POSITION TO KNOW HOW ARGENTINES ARE USING WHAT WE SUPPLY UNDER FMS CREDITS. WHILE WE RECOGNIZE WE CANNOT MONITOR MUCH OF WHAT WE SELL, IN ORDER FOR THE DEPARTMENT TO DECIDE WHETHER AND HOW TO JUSTIFY A CONTINUATION OF OUR PROGRAM IT IS ESSENTIAL THAT WE KNOW IN AS MUCH DETAIL AS POSSIBLE THE WAY IN WHICH EQUIPMENT PROVIDED UNDER PREVIOUS PROGRAM IS BEING UTILIZED. THE EMBASSY IS, THEREFORE, REQUESTED TO MAKE AN URGENT, INTENSIVE REVIEW OF UTILIZATION OF EQUIPMENT PROVIDED TO ARGENTINA UNDER FMS CREDITS DURING LAST TWO FISCAL YEARS (75 AND 76) AND REPORT IN DETAIL PRIOR TO FEBRUARY 4.
