SUBJECT: U.S.-ARGENTINE RELATIONS

1. DEPARTMENT UNDERSTANDS THAT ARGENTINE AMBASSADOR AJA
ESPIL RETURNED TO BUENOS AIRES THIS PAST WEEKEND. WHILE
HE RETURNED TO BRING HIS WIFE BACK TO WASHINGTON, HE WILL
SURELY TAKE ADVANTAGE OF HIS TRIP TO DISCUSS BILATERAL
RELATIONS WITH HIS PRINCIPALS. WITH THIS IN MIND, ARA/ECA
OFFICER ADVISED ARGENTINE POLITICAL COUNSELOR BEAUGE ON
JANUARY 29 OF SERIOUS THOUGHT WHICH DEPARTMENT IS NOW
GIVING TO U.S.-ARGENTINE RELATIONS. AFTER CONVERSATION,
BEAUGE SAID HE WOULD MAKE SURE HIS AMBASSADOR IS FULLY
INFORMED OF POINTS MADE BY DEPTOFF. ARA/ECA OFFICER ALSO
HELD BRIEF CONVERSATION ON JANUARY 31 WITH ARGENTINE EMBASSY
FIRST SECRETARY URRUTIA CONCERNING FY 1977 FMS CREDITS.

MAIN POINTS OF BOTH CONVERSATIONS ARE REPORTED BELOW.

2. ARA AUTHORIZED FERNANDO RONDON OF ECA TO MAKE APPROACH
TO BEAUGE BECAUSE OF CLOSE TIES BETWEEN TWO OFFICERS AND
DESIRE TO GET FEEDBACK. DEPTOFF MADE FOLLOWING POINTS:

-- WE WOULD NOT LIKE TO SEE USEFUL RELATIONS BETWEEN TWO
COUNTRIES IMPAIRED OVER HUMAN RIGHTS, TO WHICH NEW ADMINIS-
TRATION ATTACHES TREMENDOUS IMPORTANCE.

-- CONGRESSIONAL DISCUSSION OF ARGENTINA IS LIKELY IN
NEAR FUTURE, WHETHER CONGRESSMAN FRASER INITIATES IT OR
HOUSE COMMITTEE WHICH WILL REVIEW MILITARY ASSISTANCE
REQUESTS DOES.

-- DURING DECEMBER VISIT TO ARGENTINA BY ARA DEPUTY
ASSISTANT SECRETARY BRAY, LATTER WAS VERY FRANK IN EXPLAIN-
ING TO GOA THAT HUMAN RIGHTS CONCERNS ARE NOT THE PRE-
OCCUPATION OF A FEW IN CONGRESS BUT REPRESENT BASIC
POLITICAL FORCES AT WORK IN UNITED STATES.

-- ARGENTINE GOVERNMENT IS FULLY AWARE THAT TWO MINIMAL
STEPS MUST BE TAKEN URGENTLY,

NAMELY: A LIST OF DETAINEES MUST BE
PUBLISHED AND RIGHT WING TERROR MUST BE PUNISHED.
