1. THE EMBASSY CONSIDERS YOUR TRIP TO BE OF GREAT IMPORTANCE,
WE HAVE PREPARED A TENTATIVE SCHEDULE DESIGNED BOTH TO PROVIDE YOU
WITH BACKGROUND AND CURRENT INFORMATION ON THE ARGENTINE HUMAN
RIGHTS SITUATION, AND ACQUAINT YOU PERSONALLY WITH A SPECTRUM
OF THE PRINCIPALS THEMSELVES. GIVEN YOUR RESPONSI-
BILITIES, WE ALSO LOOK FORWARD TO HEARING YOUR VIEWS ON OUR
HUMAN RIGHTS POLICY TOWARD ARGENTINA AND OTHER AREAS OF THE
WORLD; AND WE HAVE ARRANGED FOR YOU TO SPEAK TO THE ENTIRE STAFF.

2. IT WAS OUR ORIGINAL HOPE TO HAVE YOU AS OUR GUEST AT THE
RESIDENCE. HOWEVER, AFTER REFLECTION AND CONSULTATION WITH MY
STAFF, I BELIEVE YOUR MISSION WOULD BE FURTHERED
IF YOU WERE TO STAY AT A HOTEL, WHICH WOULD PROVIDE YOU WITH
THE GREATER DEGREE OF FLEXIBILITY AND INDEPENDENCE THAT YOU
WILL NEED. RESERVATIONS HAVE BEEN MADE FOR YOU AND MR. RONDON
