Dear Mr. Secretary:

I want to personally thank you for taking so much of your valuable time to meet with members of the 94th and 95th New Members Caucus on Tuesday morning. I want to also thank you for being so very open and candid with us during the questioning period.

One of the members from the 95th Caucus, that is a newly-elected member, asked me as you were leaving, "Well, what do you think of Secretary Vance?" I replied, "Let me answer this way: You should have been here when Kissinger was Secretary of State. First of all, he would never have come down here to meet with us. Secondly, he probably never would have condescended to answer our questions, except in only the most general and non-committal way. And thirdly, if he had spent 15 minutes with us, it would have been amazing in itself. So as far as I am concerned, Secretary Vance is indeed a breath of fresh air in that position." Anyway, I think most of the members who were there that morning were highly impressed with your openness and candor with us.

You may recall that I brought up the point regarding your visit to Argentina. In my question I referred to a letter sent to you by Congressman Toby Moffett from Connecticut. (I am attaching a copy of that letter.) I do hope you will be able to bring up with General Videla the situation regarding the seven political prisoners named in that letter. After your return, I would certainly be interested in learning either from you or from Doug Bennet the situation on the "right of option" that General Videla says he will restore. I also understand you plan to discuss with General Videla the "disappeared people" in Argentina and what is being done to account for them. I am very interested in knowing his responses on this situation too.

Again, Mr. Secretary, thank you. I wish you all the best on your trip to Argentina.

Dear Secretary Vance:

I am writing on behalf of seven Argentine political prisoners who will be eligible for release on November 10. The seven are Edith Stahelli de Frias, Susana Pioli, Eduardo Gonzales, Eduardo Grutsky, Ruben Piazza, and Juan Gonzalez.

All of these prisoners will complete their three-year sentences next month. They are among the first to have been arrested under state of seige provisions; all have been mistreated and several tortured during their detainment.

I am concerned that these seven prisoners will not be released at the completion of their sentences. Recently three of them have been severely punished in prison, and one disappeared for ten days during which time he was "interrogated" and tortured. The timing of this intensified harassment, and the well-documented evidence of excesses committed by the security forces, suggest that the lives and rights of these prisoners are in serious jeopardy.

In your upcoming talks with General Videla, I ask you to urge him to follow through on his promise to restore the right of option for all prisoners held under the state of seige, and to release prisoners when their sentences are completed. I ask you especially to inquire into the cases of these seven prisoners, to ensure their release.

Thank you for your attention to this matter.
