Terrorism

- \*2 - Understand your terrible problems - *Sympathy*
- And exasperation you must feel when international opinion seems to ignore your struggle.
- Particularly as international terrorism troubles many governments.
- *Such* This negative reaction is to be expected, however, when counter-terrorist actions violate human rights and are outside the rule of law. Governments are expected to accord due process to all accused.

- \*3 - You know the concern of President Carter, our government and people for the fate of many individuals.
- I have carried here a large list of 7,500 names, compiled by a group of respected organizations (disclaimer of perfection of list). *Detainees or disappearance -*
- In addition I have also brought a number of other names at the request of some members of our Congress and other individuals.

  - In particular the Timmerman and Deutsch family cases are being viewed with grave concern -- in our country and abroad. As, in addition to their personal fates, they symbolize growing worry about anti-Semitism.
  
- \*5 - Right of Option
  - We are concerned that implementation of the right of option is taking so long, so complex and reaching so few people.
  
- \*6 - Torture
  - We know your own feelings on torture.
  - And that you are as troubled as we are by reports that torture continues to accompany detention.
