SUBJECT: DISAPPEARANCE OF MOTHERS GROUP'S SUPPOR

SUMMARY: OVER THE WEEKEND ARGENTINE AUTHORITIES 6 (GDA) MADE TWO DRAMATIC ANNOUNCEMENTS REGARDING THE DEC. 8-10 DISAPPEARANCES OF 13 PERSONS THE DEC. 8-10 DISAPPEARANCES OF 13 PERSONS
ASSOCIATED WITH THE MOTHERS OF THE PLAZA DE MAYO ON FRIDAY NIGHT (12/16) THE GOVERNMENT'S INFORMATION OFFICE ISSUED A CAREFULLY WORDED COMMUNIQUE REPUBLATING ANY GOVERNMENT INVOLVEMENT AND BLAMING SUBVERSIVE HIHILISM FOR THE DISAPPEARING THE FOLLOWING NIGHT (12/17) THE FIRST ARMY COMMAND ISSUED A BULLETIN ANNOUNCING THAT THE MONTONERO ORGANIZATION HAD CLAIMED RESPONSIBILITY FOR THE KIDNAPPING OF THE TWO FRENCH NUNS AND HAD MADE FOUR DEMANDS, INCLUDING THE FREEING OF 21 POLITICAL PRISONERS, FOR THEIR RELEASE. THE MONTONERO PLOY IS, HOWEVER, WIDELY DISBELIEVED, AND FAMILY MEMBERS OF SOME OF THE DISAPPEARED PERSONS CALLED ON THE FRENCH AND AMERICAN EMBASSIES ON MONDAY (12/19) TO REGISTER THIS DOUBT AND URGE THAT DIPLOMATIC PRESSURE BE BROUGHT AGAINST GOA TO FORCE IT TO PRODUCE THE PERSONS ABDUCTED. WE ARE USING ALL EMBASSY RESOURCES TO TRY TO SORT OUT WHAT MAY ACTUALLY HAVE HAPPENED TO THE PERSONS ABDUCTED. ELEMENTS OF THE GOVERNMENT CONTACTED CONTINUE TO PROFESS MYSTIFICATION AND AT THE SAME TIME PRIVATELY TO DERIDE THE "MONTONERO PLOY". END SUMMARY

- 1. THE GOVERNMENT OF ARGENTINA BROKE ITS OFFICIAL SILENCE REGARDING THE DISAPPEARANCES OF AT LEAST 13 MEMBERS AND SUPPORTERS OF THE "MOTHERS OF THE PLAZA DE MAYO", AFTER A WEEK OF CONSIDERABLE DIPLOMATIC AND PRESS INTEREST, BY ISSUING AN INTRICATELY WORDED COMMUNIQUE LATE DECEMBER 17. THE PRESIDENCY'S COMMUNIQUE OBLIQUELY MADE THREE POINTS-THE GOVERNMENT WAS NOT INVOLVED IN THE DISAPPEARANCES; "NIHILISTIC SUBVERSION" WAS RESPONSIBLE FOR THESE ACTIONS; AND L'ASTLY, THE GOVERNMENT PRESCRETED THIS ATTEMPT TO CAUSE CONFRONTATIONS WITH OTHER COUNTRIES, THE CHURCH, AND FAMILIES CAUGHT UP IN EXTREMIST VIOLENCE. THE GOVERNMENT'S ANNOUNCEMENT DID NOT ANSWER QUESTIONS REGARDING CIRCUMSTANCES OF THE DISAPPEARANCES OR DISPEL THE STRONG NEGATIVE REACTIONS IN FRANCE TO THE DISAPPEARANPO OF TWO NUMS FROM A TOULOUSE ORDER.
- 2. THE FOLLOWING NIGHT (12/17) IN AN UNUSUAL COMMUNIQUE THE FIRST ARMY COMMAND ANNOUNCED THAT THE AGENCE FRANCE PRESSE HAD RECEIVED A COMMUNICATION EARLIER THAT DAY FROM THE MONTONERO ORGANIZATION CLAIMING CREDIT FOR THE

KIDNAPPING OF THE TWO FRENCH NUNS, SISTER ALIGIA AND SISTER LEONIE. ACCORDING TO THE ARMY COMMUNIQUE THE "MONTONERO" DOCUMENT DEHANDED:

- A. THAT THE CATHOLIC CHURCH ISSUE A DOCUMENT REPUDIATING THE PRESENT ARGENTINE GOVERNMENT;
- B. THAT THE FRENCH GOVERNMENT ISSUE A DOCUMENT REPUDIATING THE PRESENT GOVERNMENT AND GRANT ASYLUM TO ARGENTINE POLITICAL PRISONERS;

C. THAT THE MILITARY JUNTA SUBMIT A PUBLIC REPORT TO THE UNITED NATIONS REGARDING THE STATUS OF DETAINED AND DISAPPEARED PERSONS IN ARGENTINA;

D. AND, THAT 21 "CRIMINAL SUBVERSIVES" (SEE LIST
BELOW) BE RELEASED. THE ARMY COMMUNIQUE THEN WENT TO
REPEAT PARTS OF THE PREVIOUS DAY'S PRESIDENTIAL OFFICE ANNOUNCEMENT. THE COMMUNIQUE WAS GIVEN WIDE PLAY IN THE ARGENTINE PRESS WITH NO COMMENT.

3. THE FRENCH PRESS AGENCY IN FACT DID RECEIVE THREE
DOCUMENTS IN THEIR NOON MAIL ON SATURDAY, DECEMBER 17-THE "MONTONERO" LETTER, A HANDWRITTEN LETTER IN
FRENCH FROM SISTER ALICIA AND A 6 X 8 GLOSSY PHOTOGRAPH
OF THE TWO FRENCH CAPTIVE NUNS SEATED BELOW A MONTONERO
FLAG HOLDING A COPY OF THE DECEMBER 14 EDITION OF "LA
NACION". THE "MONTONERO" LETTER STATED THAT ON
DECEMBER 8 AND 18 TWO COMBAT CELLS OF THE MONTONERO ARMY
HAD DETAINED THE TWO FRENCH NUNS. (NO MENTION WAS MADE OF THE
DETENTION HAD TAKEN PLACE IN ORDER TO OBTAIN CERTAIN
STATEMENTS FROM THE GOVERNMENT OF FRANCE, THE CATHOLIC
CHURCH, AND THE ARGENTINE MILITARY GOVERNMENT AND TO
FREE BEFORE DECEMBER 24 THE FOLLOWING PERSONS:
