SUBJECT ARGENTINE HUMAN RIGHTS

1. I APPLAUD THE DEPARTMENT FOR A POSITIVE AND MOST TIMELY INITIATIVE IN ITS EFFORT TO BRING ARGENTINA BACK TO THE RULE OF LAW.
2. IT IS TIMELY BECAUSE THE SUCCESSION ISSUE ITSELF HAS JUST BEEN SOLVED, IF NOT ALL THE ASSOCIATED ISSUES. HAD THAT NOT BEEN RESOLVED, AN INITIATIVE SUCH AS THAT PLANNED WOULD HAVE HAD LITTLE CHANCE. WE DO NOT SEE THE WORLD CUP GAMES AS A DEVELOPMENT THAT WILL TOTALLY DISTRACT THE ATTENTION OF THE LEADERSHIP. IT IS NOT A DIVISIVE ISSUE, RATHER ONE ON WHICH THEY CAN GENERALLY AGREE. THE LEADERSHIP IS UNLIKELY TO MAKE SIGNIFICANT CHANGES BEFORE THE GAMES ARE OVER, BUT THE END OF THE GAMES (ASSUMING THEY ARE NOT MARRED BY MAJOR EMBARRASSMENTS) COULD PROVIDE AN UNUSUALLY OPPORTUNE TIME FOR THE GOVERNMENT TO MAKE CHANGES. THIS BEING THE CASE, THE MISSION MIGHT VISIT ANY TIME UP

3. SUCCESSION TO THE PRESIDENCY IS NO LONGER AN ISSUE. VIDELA WILL CONTINUE AT THE HELM, BUT HE WILL NO BE COMMANDER OF THE ARMY AFTER JULY 31. VIDELAS REPLACEMENT AS ARMY COMMANDER IN THE JUNTA IS VERY MUCH AT ISSUE. THIS IS THE "KEY" SPOT AND LIKEWISE THE POWER BASE. GENERAL VIOLA IS VIDELAS ALTER EGO. VIDELA TOLD ME RECENTLY "WHEN YOU TALK TO VIOLA YOU ARE TALKING TO ME". VIDELA ENCOURAGED ME TO CONFER WITH VIOLA WHEN A MESSAGE HAD TO GET TO HIM, THUS BY-PASSING THE FONOFF. IF VIOLA MAKES IT, THE INITIATIVES CHANCES FOR SUCCESS ARE FAVORABLE. THE CONVERSE HOLDS TRUE IF HARDLINERS SUAREZ MASON OR MENENDEZ MAKE IT. THE ARMY'S OK IS A "MUST" FOR ANY SUCCESSFUL GOA COMMITMENT.

4. IN GAMBLING PARLANCE, THE INITIATIVE IS A "LONG SHOT". I SUPPORT IT FULLY, RECOGNIZING ITS PITFALLS. CHEST THUMPING IS A DAILY RITUAL AT THE CASA ROSADA AND AT MILITARY GARRISONS OVER GOAS SOVEREIGNTY. TO EVERY ARGENTINE, EXTERMINATION OF TERRORISM IS AN INTERNAL MATTER. IT IS DOUBTFUL THAT GOA IS WILLING TO SWAP SPARE PARTS OR TRAINING FOR WHAT THEY CONSIDER

"HYPOCRITICALLY" AN INFRINGEMENT OF THEIR RIGHT TO FIGHT MARXISM AND SUBVERSION. ON THE OTHER HAND, GOAS IMAGE ABROAD IS A VITAL CONCERN. MISSION HERE WITHOUT ANY ADVANCE SPADE WORK BEING DONE. IT WOULD BE A CLEAR SETBACK, IF ON THE MISSIONS ARRIVAL THE GOA WOULD TAKE A NEGATIVE OR HOSTILE STANCE. THIS COULD OCCUR IF VIDELA, VIOLA, AND HARGUINDEGUY FELT THEY WERE BEING TAKEN UNAWARE AND THAT THEIR HANDS WERE BEING FORCED.

5. I PROPOSE THAT I BE AUTHORIZED TO MAKE THE FOLLOWING APPROACH TO GENERAL VIOLA, STATING THAT THE SECRETARIES OF STATE AND DEFENSE ARE CONCERNED ABOUT THE DETERIORATION OF OUR RELATINS AND WOULD HOPE TO SEND A HIGH-LEVEL MISSION TO BUENOS AIRES TO CONSULT AT THE APPROPRIATE LEVEL TO SEE IF THIS TREND MIGHT BE ARRESTED. RECOGNIZING THAT US LAW PROHIBITS SALES OF EXPORTS OR TRAINING AND MILITARY EQUIPMENT AFTER SEPT 30 AND THAT EVENTS IN ARGENTINA HAVE NOT CHANGED ENOUGH TO CONVINCEN OUR CONGRESS THAT THIS LEGISLATION SHOULD BE WITHDRAWN, WE WOULD LIKE TO EXPLORE SERIOUSLY TO SEE HOW IT MAY BE POSSIBLE TO REVERSE THIS TREND. IF THE SECURITY OPERATION PRACTICES IN ARGENTINA CHANGE IN SOME MAJOR RESPECT IN THE NEAR FUTURE (WE HAVE HAVE PARTICULARLY IN MIND THE NORMALIZATION OF ARREST PROCEDURES IN CASES OF SUSPECTED SUBVERSIVE ACTIVITY), THE USG WOULD BE IN A POSITION TO ACKNOWLEDGE THIS POSITIVE DEVELOPMENT AND TO AUTHORIZE SOME SALES OR LICENSES AS AN INDICATION OF PROGRESS TOWARD NORMAL RELATIONS. IF THE GOA WOULD BE WILLING TO RECEIVE A HIGH LEVEL USG MISSION TO EXPLORE THIS SUBJECT, WE WILL RESPOND PROMPTLY.
