SUBJECT HUMAN RIGHTS AND US PROGRAMS IN ARGENTINA

REF: STATE 162533

1. I READ STATE 162533 WITH DEEP CONCERN. DUE TO A SEEMING LACK OF CLARITY ON THE EXACT NATURE OF THE MESSAGE TO BE CONVEYED TO GOA, I FELT IT WISE TO BE PRUDENT AND CAUTIOUS ON MY APPROACH TO GENERAL VIOLA. MY MESSAGE TO GOA, IF IT FOLLOWED EXACTLY THE WORDING OF THE CONTENTS OF STATE REFTEL COULD POSSIBLY EVEN BE INTERPRETED AS A DESIRE FOR COMPLETE SEVERANCE IN RELATIONS.

2. I MET WITH GENERAL VIOLA AT 11:45 THIS MORNING IN HIS OFFICE. I HAVE FRIENDLY WORKING RELATIONS WITH VIOLA, AS WELL AS PRESIDENT VIDELA, SO I COULD DISPENSE WITH THE USUAL NICETIES OF DISCUSSING WEATHER, WORLD CUP, ETC. I TOLD VIOLA THAT I WAS THE BEARER OF BAD TIDINGS, BUT I BELIEVED THAT THERE WAS STILL ROOM TO SAVE THE DAY.

3. I TOOK OUT MY HAND-WRITTEN NOTES, IN ORDER TO BE SURE I WAS NOT OMITTING ANY OF THE SALIENT POINTS IN REFTEL. I ADVISED VIOLA THAT THE USG WAS DISAPPOINTED IN THE CONDITIONAL INVITATION THE GOA EXTENDED TO IAIRC.

I SAID THAT THE IAIRC HAS NOT TO THIS DATE ACCEPTED THE GOA INVITATION.

4. I FURTHER TOLD VIOLA THAT RELEASES OF DETAINEES WAS NOT MOVING AS PER EXPECTATIONS. I REMINDED HIM OF MY LAST CONVERSATION WITH HIM ON LACK OF ORGANIZATION IN THE HANDLING OF THE RIGHT OF OPTION CASES.

5. VIOLA IS USUAL PLACID, SMILING AND FRIENDLY MILITARY COMMANDER. BY THIS TIME, HE LOOKED LIKE A GHOST AND HIS LIPS WERE QUIVERING. HE MANAGED TO TELL ME THAT HE DIDN'T THINK THE USG WOULD BE EXPECTING SUBSTANTIAL RESULTS IN SUCH A SHORT TIME -- REFERRING TO NEWSOM VISIT. HAVING DIFFICULTY IN SPEAKING, HE MUMBLED THE WORLD CUP HAD SAPPED ALL OF ARGENTINA OF ITS ENERGY AND GOA HAD ALMOST COME TO A COMPLETE STOP FOR A MONTH. HE SAID HE FELT THE USG WAS BEING SOMEWHAT INCONSIDERATE.

6. I INTERRUPTED GENERAL VIOLA AND SAID THAT I HAD EVEN WORSE NEWS FOR HIM. I SAID BECAUSE OF A NON-ACCEPTANCE BY THE IAIRC OF THE CONDITIONAL GOA INVITATION, NO MILITARY TRAINING WAS TO BE MADE AVAILABLE. I ADDED THAT EXIM BANK, ON

FOREIGN POLICY GROUNDS, WOULD BE TOLD NOT TO CONSIDER ARGENTINE FINANCING, WITH SPECIAL EMPHASIS ON THE YACYRETA HYDRO-ELECTRIC PROJECT. I EXPLAINED TO HIM THAT THE BOEING AIRCRAFT ALSO COULD NOT BE FINANCED BY EXIM BANK, BUT THE USG HAD NO OBJECTION IF THE GOA COULD GET PRIVATE FINANCING.

7. BY THIS TIME VIOLA WAS SPEECHLESS. HE STARED AT ME AS IF THOUGH THE RUG HAD BEEN PULLED OUT UNDER HIM. HE HAD PREVIOUSLY TOLD ME THAT MILITARY TRAINING WAS THE KEY GOA

REQUEST. SENSING HIS FRUSTRATION, I INFORMED HIM THAT I WAS GOING TO WASHINGTON ON JULY 9. I SUGGESTED THAT I WOULD LIKE TO SEE HIM AGAIN BEFORE MY DEPARTURE. I ALSO EXPLAINED I FELT BOUND TO DISCUSS THE ENTIRE SUBJECT WITH THE FONMIN. I ALSO SUGGESTED THAT SINCE MONTES WAS JUST RETURNING FROM WASHINGTON TODAY AND WOULD BE TOO TIRED TO SEE ME NOW, AND PERHAPS ALSO DISAPPOINTED WITH HIS EFFORTS. I SAID I WANTED TO SEE THE FONMIN WHEN CONDITIONS WERE RIGHT AND I WOULD DEPEND ON HIM TO SO INFORM ME.

8. VIOLA TO COPIOUS NOTES. HE SAID HE WOULD SEE PRESIDENT VIDELA AND REVIEW THE WHOLE SUBJECT WITH HIM. I SUGGESTED TO VIOLA THAT THIS WHOLE MATTER SHOULD BE TREATED WITH THE PRESIDENT AND OTHER MILITARY COMMANDERS IN A LOW KEY. I FELT SUDDEN OUTBURSTS AGAINST THE USG OR RECRIMINATORY ACTS MIGHT TEND TO PRECIPITATE FURTHER DISRUPTION OF RELATIONS. I SAID I FELT THERE WAS STILL ROOM FOR FLEXIBILITY. I EMPHASIZED WE CHERISHED THEIR FRIENDSHIP.

9. I REQUESTED VIOLA, IF HE COULD, TO PLEASE INFORM ME ON THE PRESIDENTS REACTION. I ALSO OFFERED TO MEET WITH THE PRESIDENT, VIOLA AND FONMIN AND OTHERS BEFORE I LEFT FOR WASHINGTON AND CONVEY WHATEVER MESSAGE THEY DESIRED. I ENCOURAGED GENERAL VIOLA TO DO WHATEVER THEY COULD TO BRING ABOUT A BROADENING OF THEIR INVITATION TO IAIRC, AS HAS BEEN DONE BY OTHER LA COUNTRIES.

10. ON MY RETURN FROM VIOLAS OFFICE, I LEARNED OF FRANK MCNEILS TELCON WITH JACK HIGGINS. I FULLY SHARE MCNEILS VIEWS AS OUTLINED TO ME BY THE ADCM. COMMENT: ARGENTINAS WORLD CUP VICTORY HAS TENDED TO INSTILL IN SOME KEY GOA LEADERS A FEELING THAT THEY ARE WORLD BEATERS NOW IN ALL ASPECTS OF LIFE. SOME HAVE BEGUN SAYING PUBLICLY THAT A HERDER LINE MUST BE TAKEN NOW IN GOA'S FOREIGN POLICY. ONE GETS THE FEELING THAT THE MORE

MILITANT ARGENTINES ARE SUDDENLY ANXIOUS TO WALK ACROSS THE ANDES AND TAKE OVER CHILE. AT THIS MOMENT, WE ALL HAVE TO BE CAREFUL NOT TO GIVE THE MILITANTS REASON TO ENCOURAGE ANTI-US OUTBURSTS. I BELIEVE I SUCCEEDED IN CONVINCING VIOLA OF THE NEED NOT TO MAKE ANY PUBLIC DECLARATIONS AT THIS MOMENT. I'M HOPEFUL THAT I ALSO IMPRESSED HIM OF NEED TO PASS ON ONLY LOW-KEY INFORMATION TO HIS SUBORDINATES. I SUGGESTED NOW IS NO TIME TO MAKE STATEMENTS THAT MIGHT LATER BE REGRETTED. I BELIEVE WE BOTH FELT THAT US/GOA RELATIONS ARE TOO IMPORTANT AND EVERY POSSIBLE EFFORT MUST BE MADE TO PRESERVE THEM ANE EVEN IMPROVE THEM. GENERAL VIOLA WAS DEEPLY PAINED BY THE MESSATE FROM WASHINGTON. I HAVE A STRONG FEELING PRESIDENT VIDELA WILL ALSO GO THROUGH AGONIZING MOMENTS. THEY SINCERELY FEEL THEY ARE THE DEFENDERS OF A FREE WORLD BY DEFEATING

TERRORISM AND THAT THE USG IS NOT GIVING THEM ENOUGH TIME
TO MOVE IN POLITICALLY DANGEROUS AREAS.
I SHALL ENCOURAGE A FOLLOW-UP WITH VIDELA AND VIOLA ASAP,
ASSUMING THEY WILL RECEIVE ME. THEIR FUTURE ATTITUDE TOWARD
THE EMBASSY MAY BE SOMEWHAT COOL.
